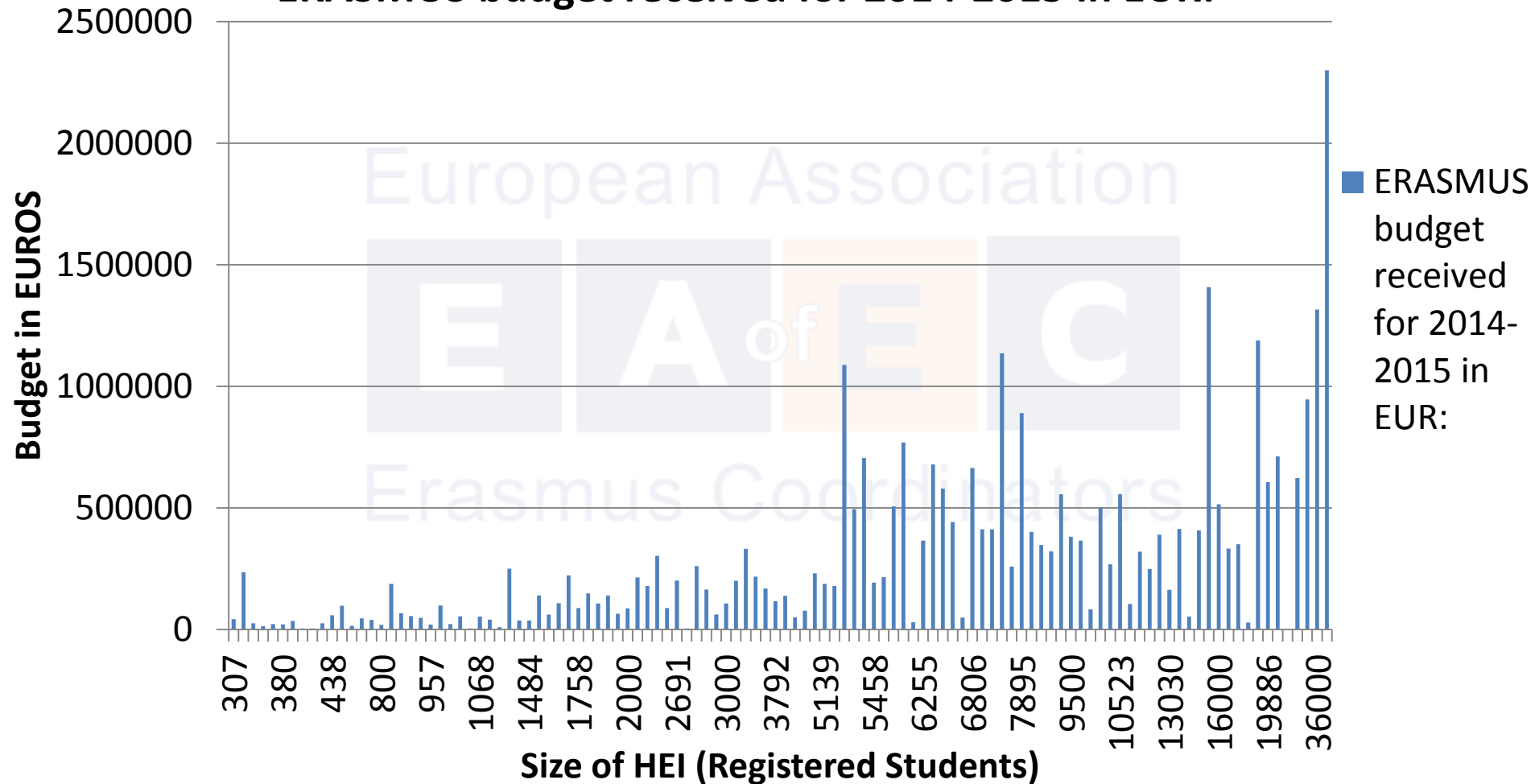

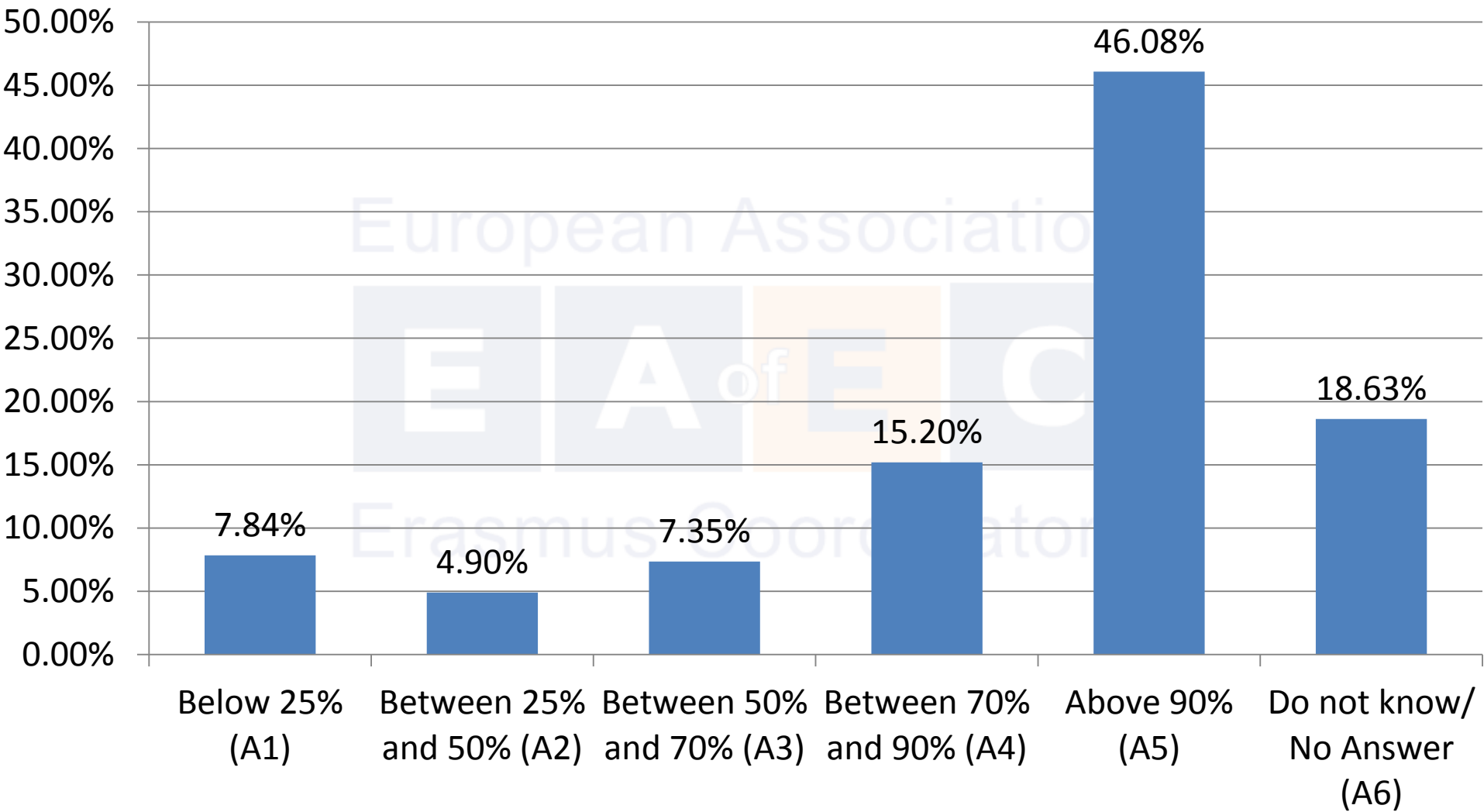
ERASMUS budget received for 2014-2015 in EUR:



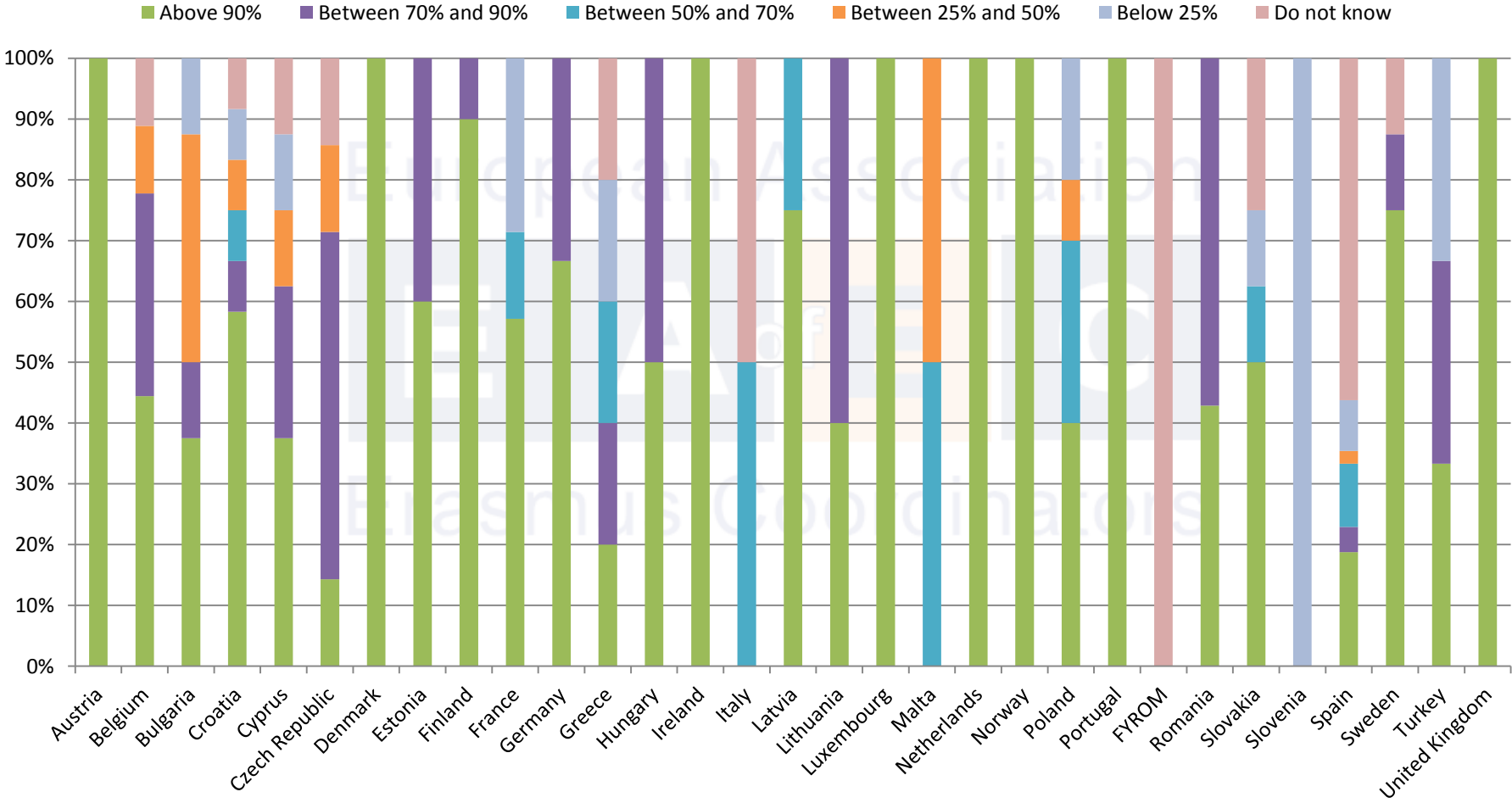

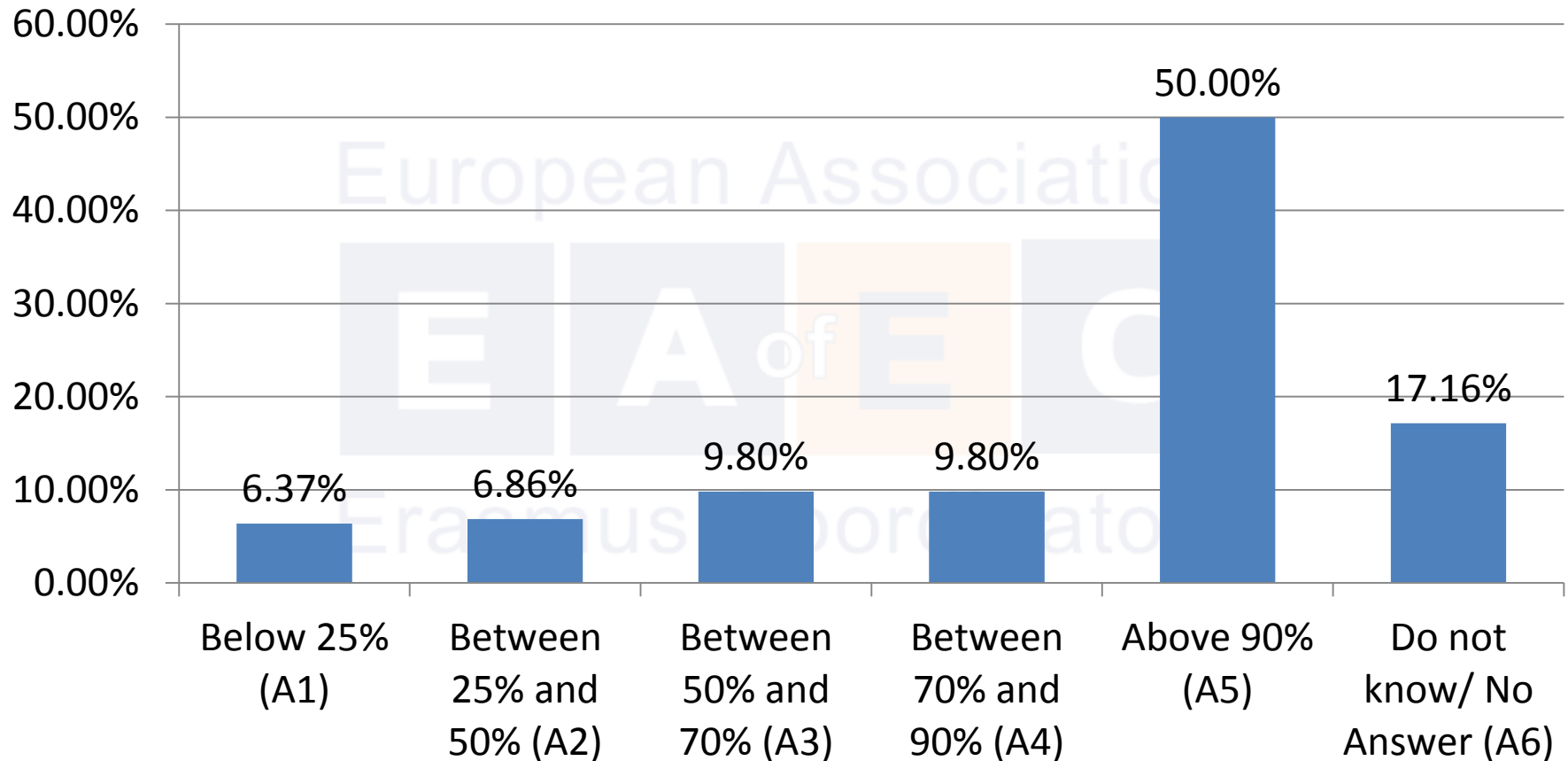
Q1. Among all the students who applied for outgoing ERASMUS studies, what is the proportion who has been selected for EU funding?



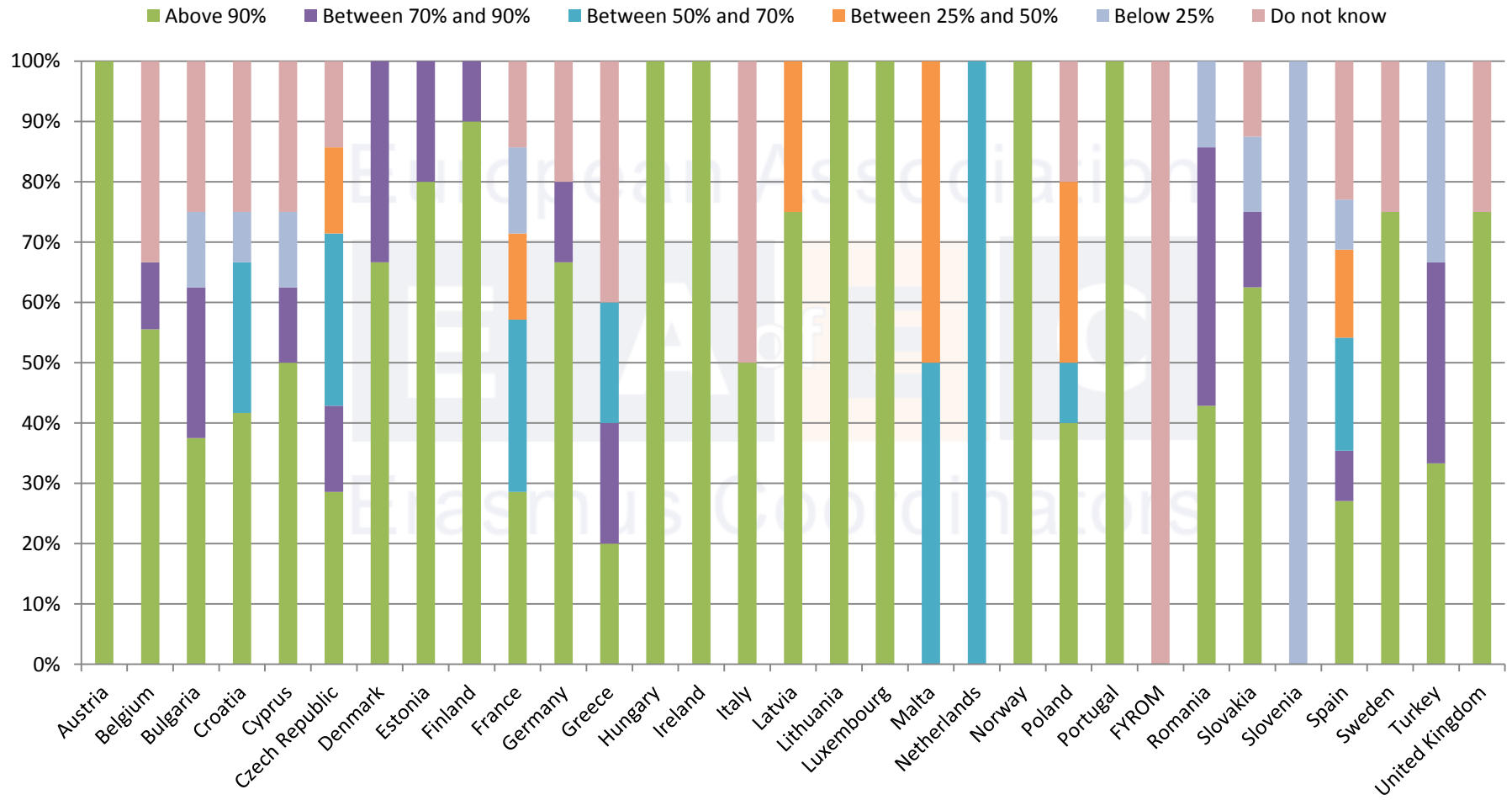
Proportion of outgoing ERASMUS students who have been selected for funding per country (Question 1)



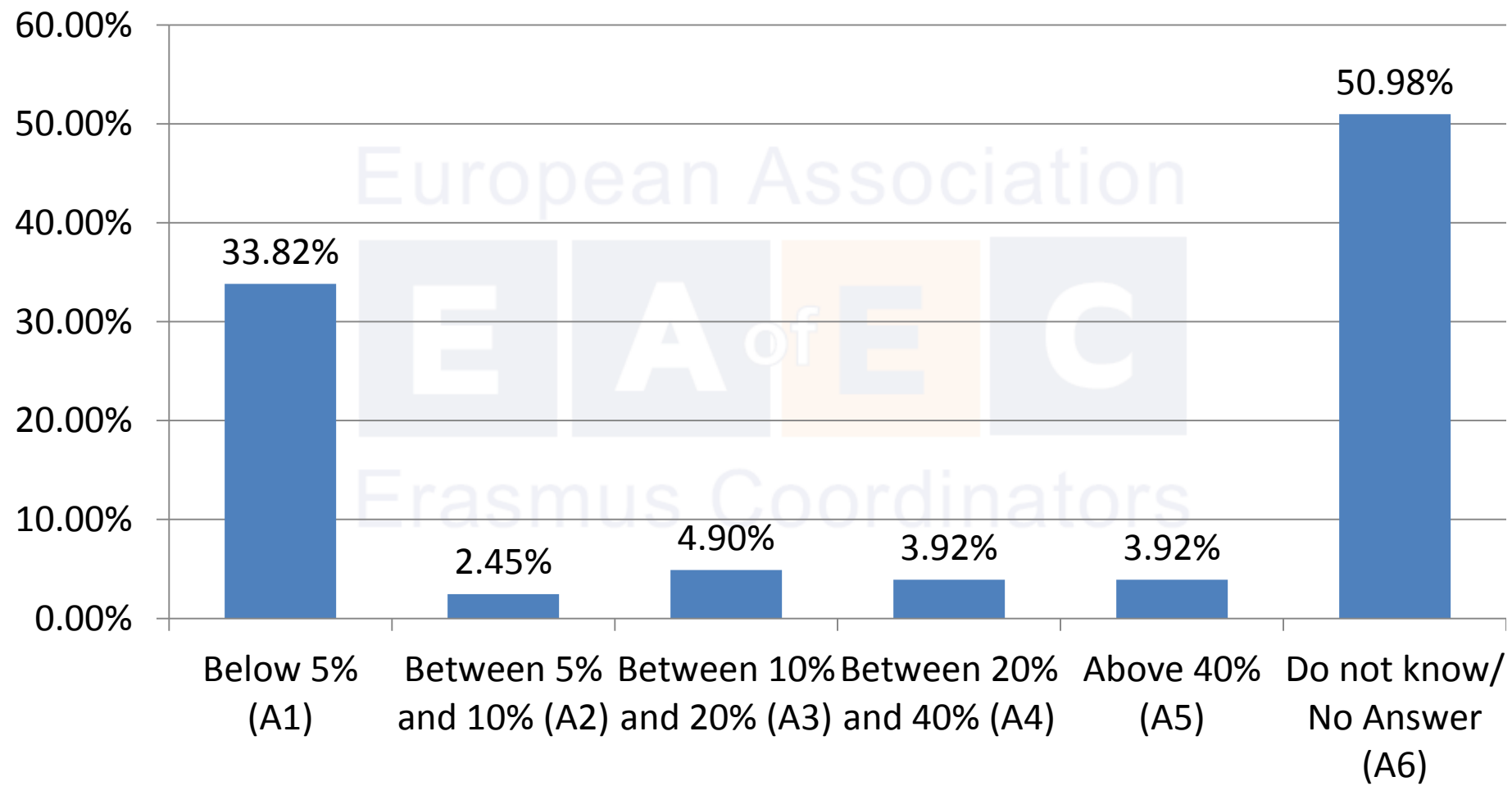
Q2. Among all the students who applied for outgoing ERASMUS traineeships, what is the proportion who has been selected for EU funding?



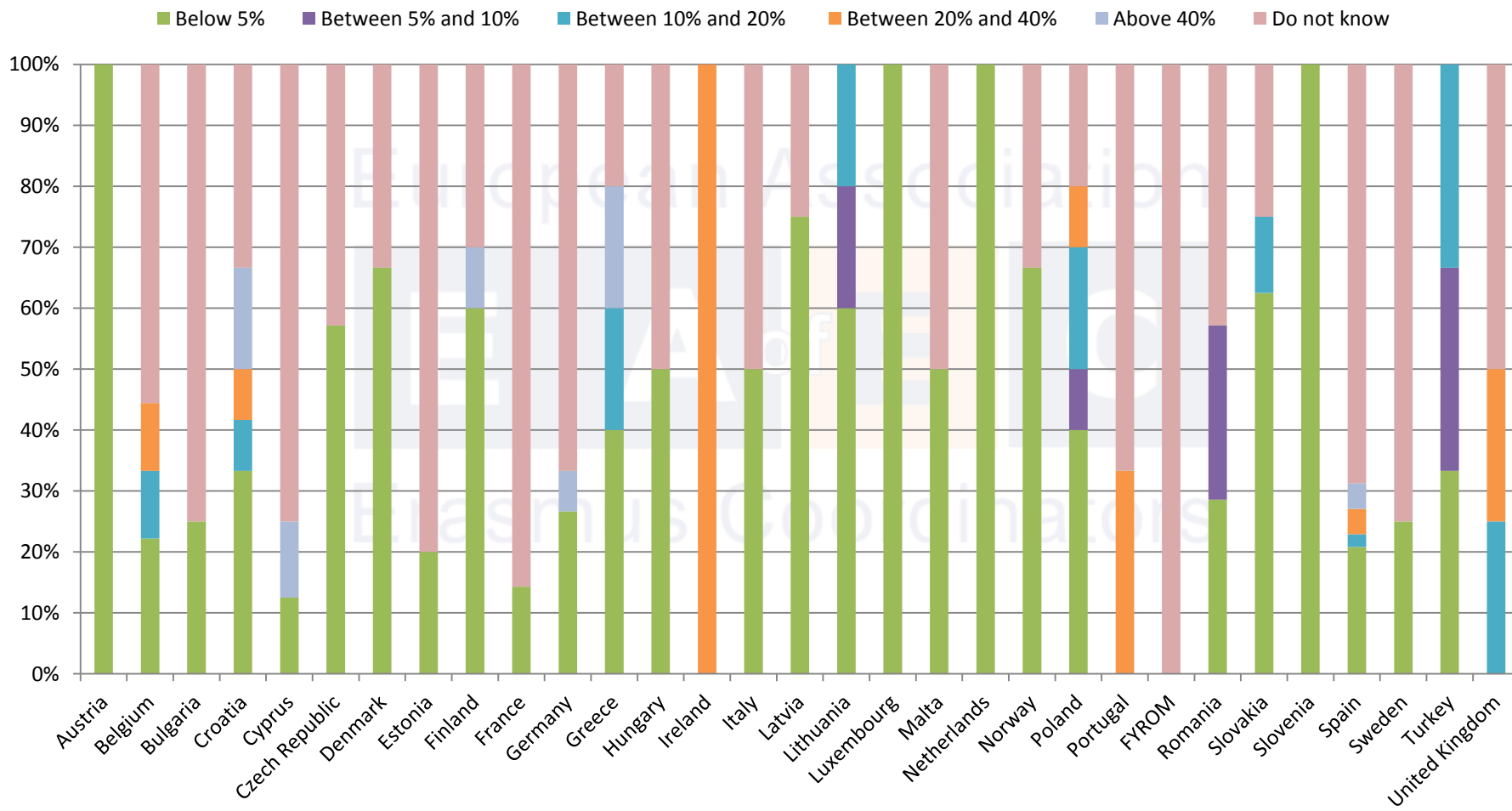
Proportion of outgoing students who have been selected for ERASMUS traineeship funding per country (Question 2)



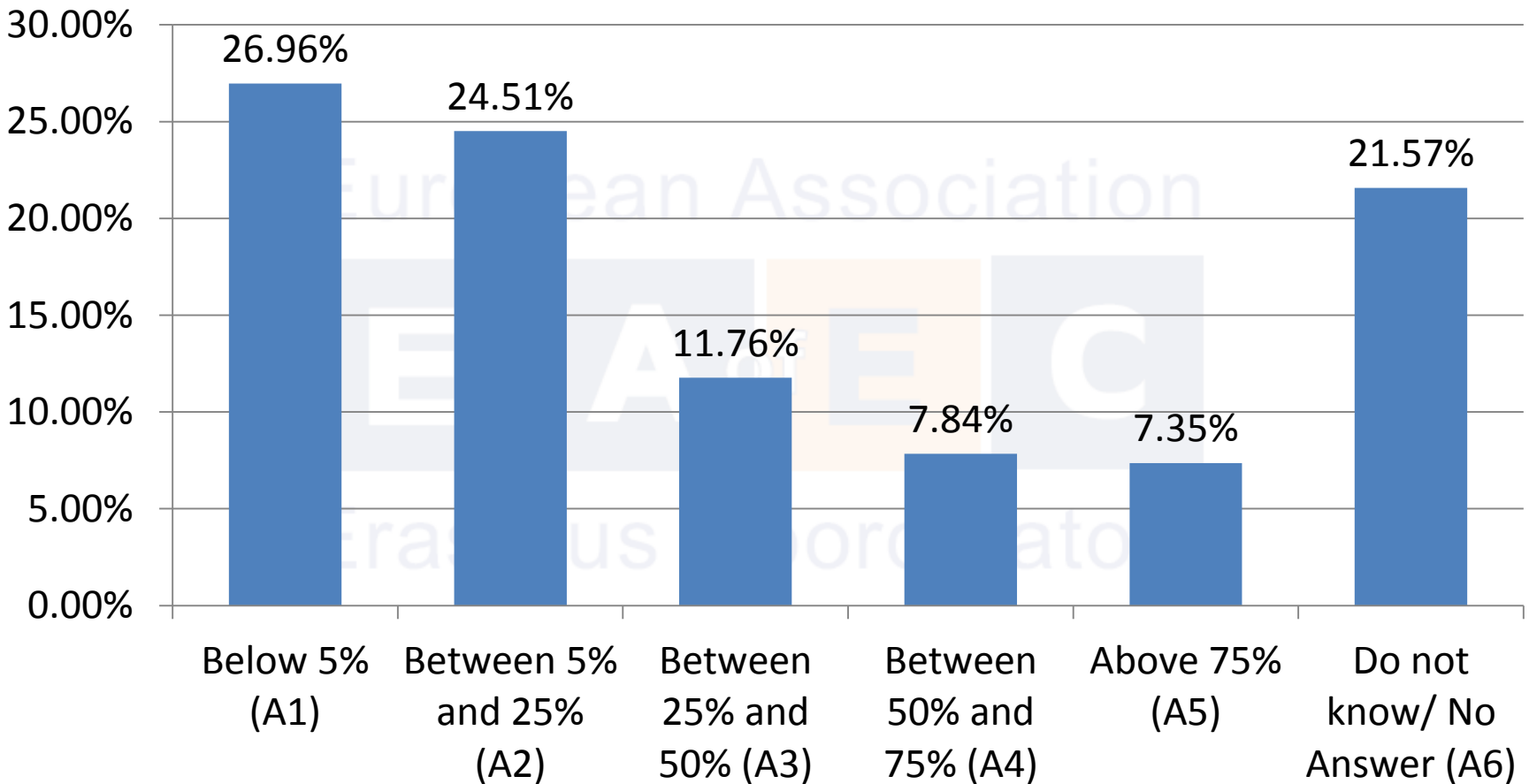

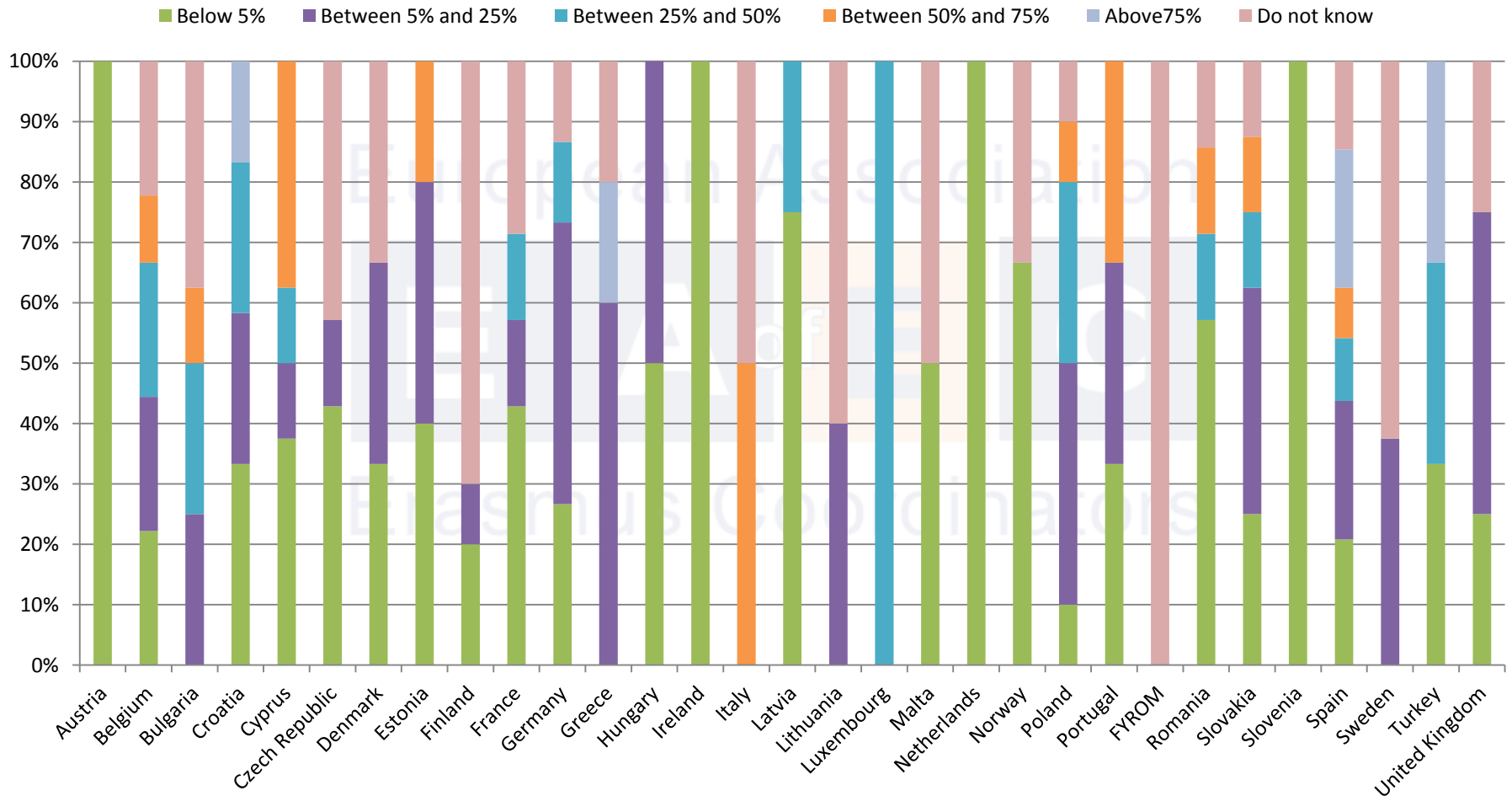
Proportion of students from a disadvantaged background that have been selected for funding and will receive a toptup per country (Question 3)



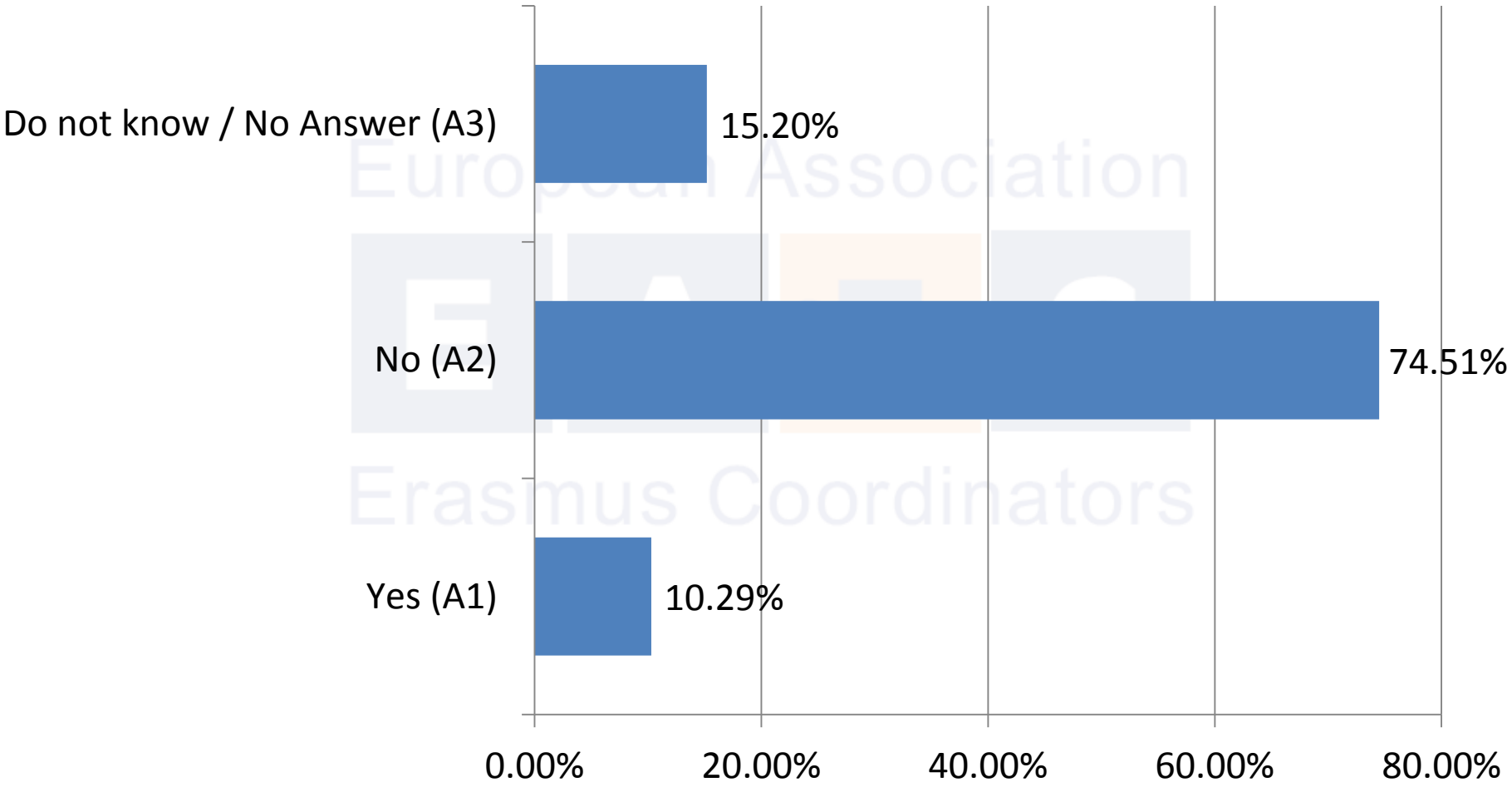

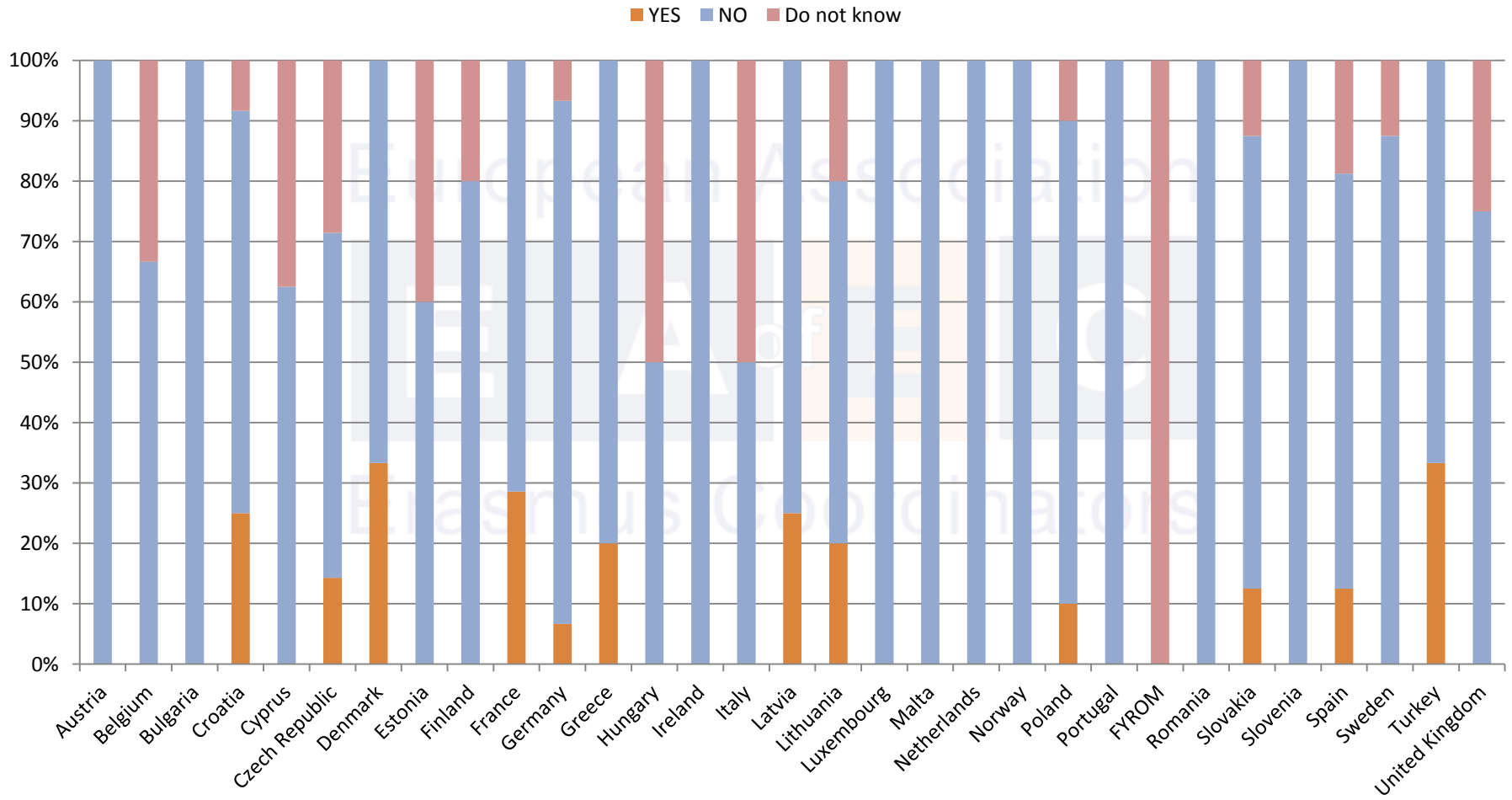
Interest of students to undertake a traineeship as recent graduates per country (Question 4)

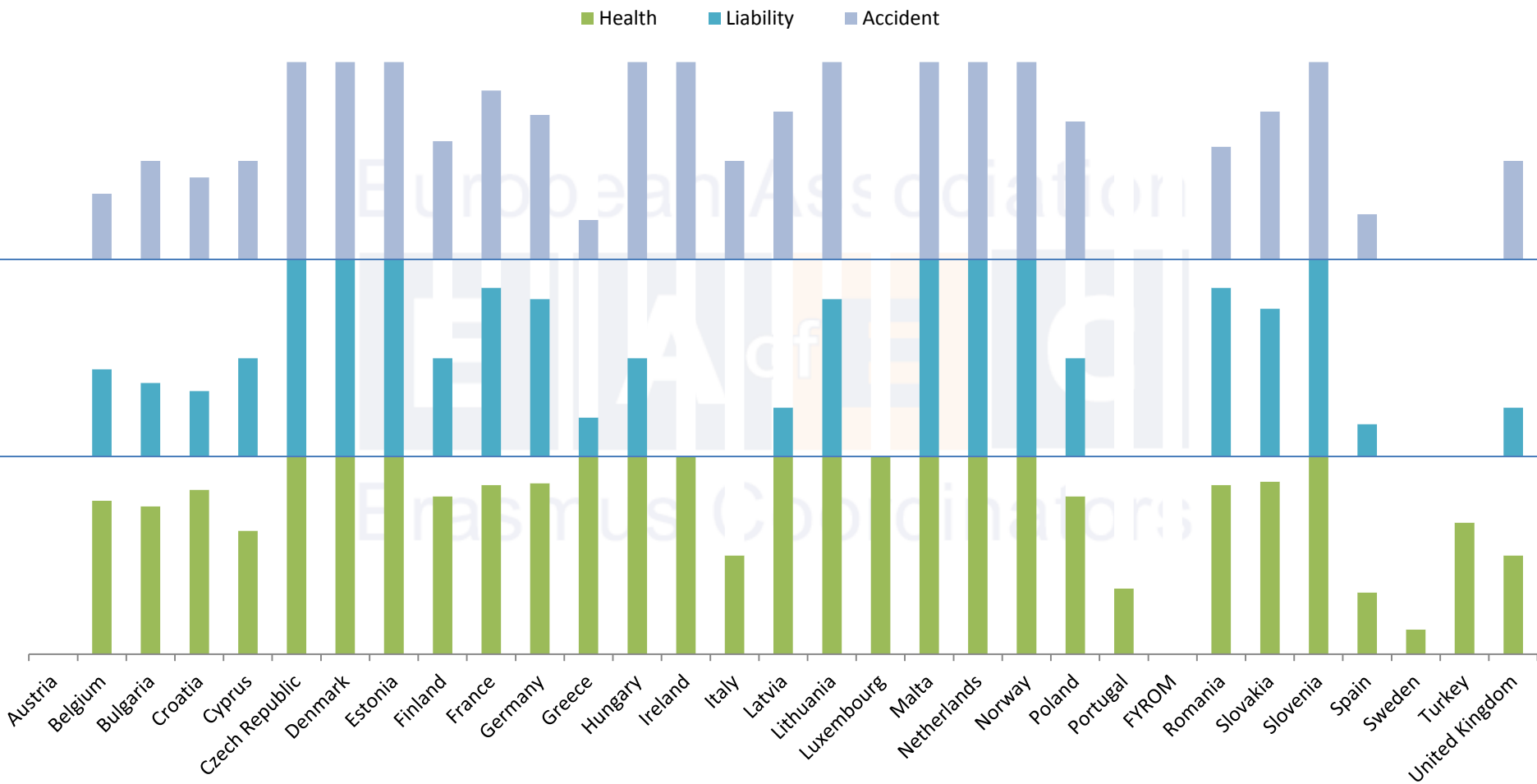

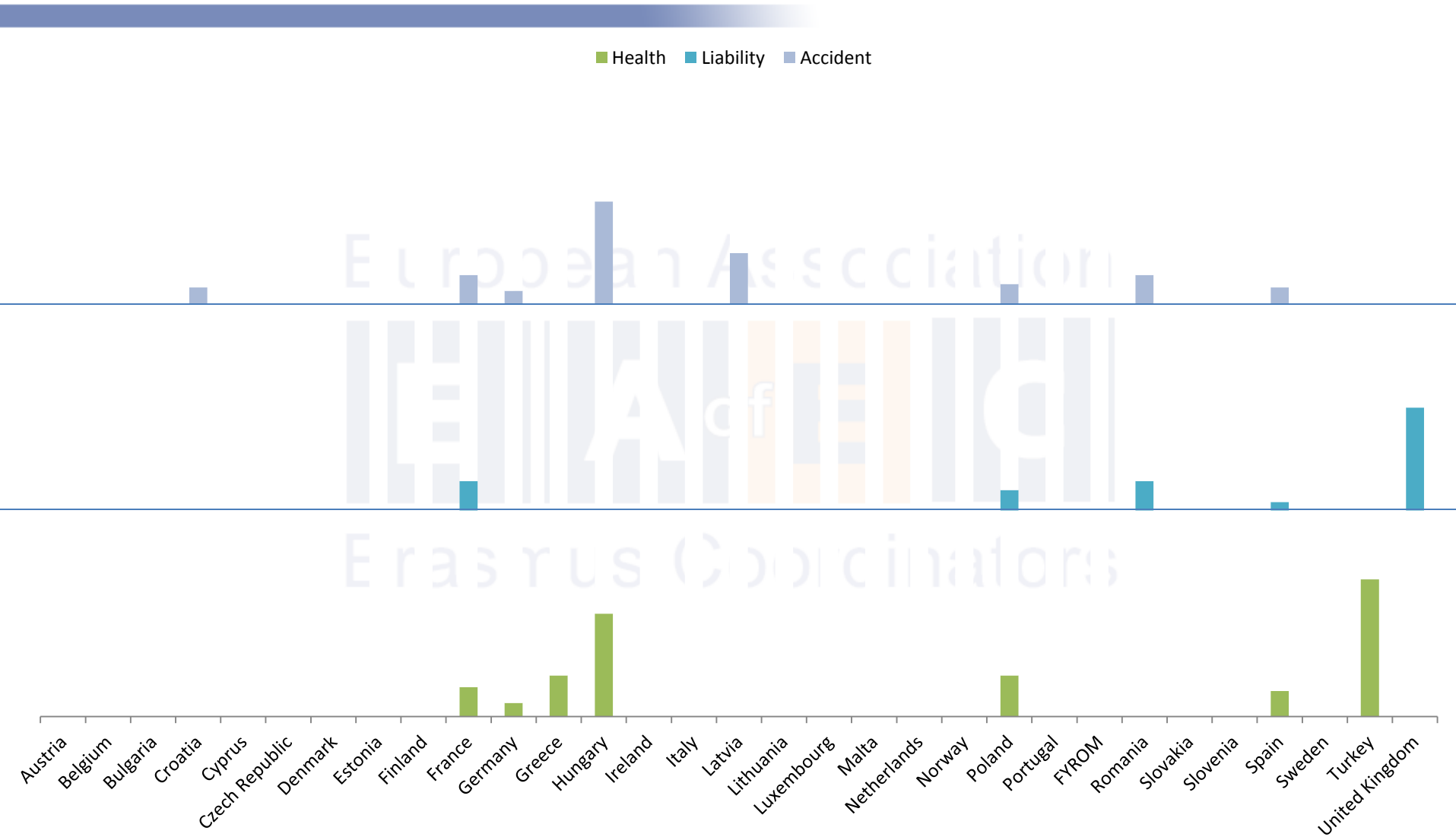
What type of insurance do students most often taking care of (Question 6)

What type of insurance do receiving HEIs most often taking care of (Question 6)



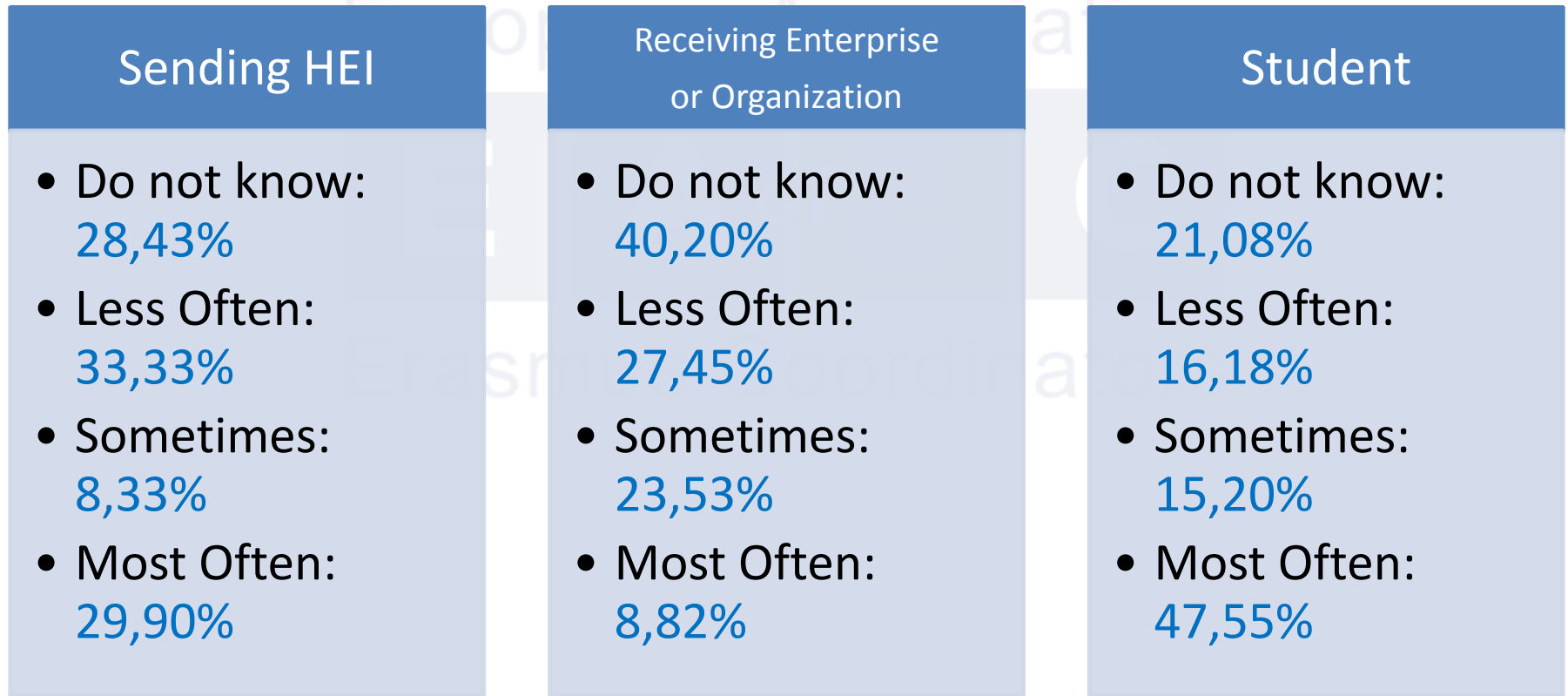

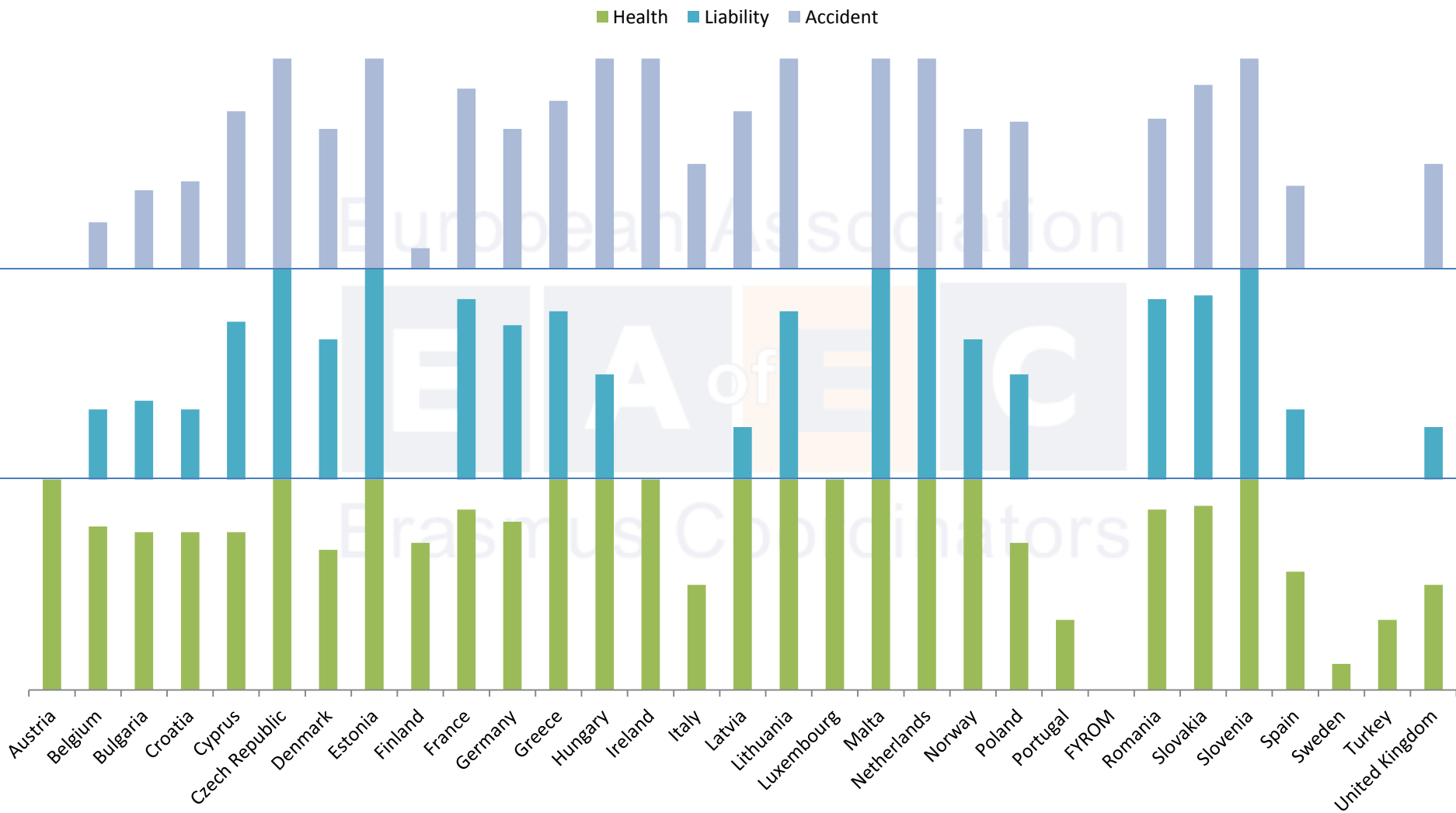

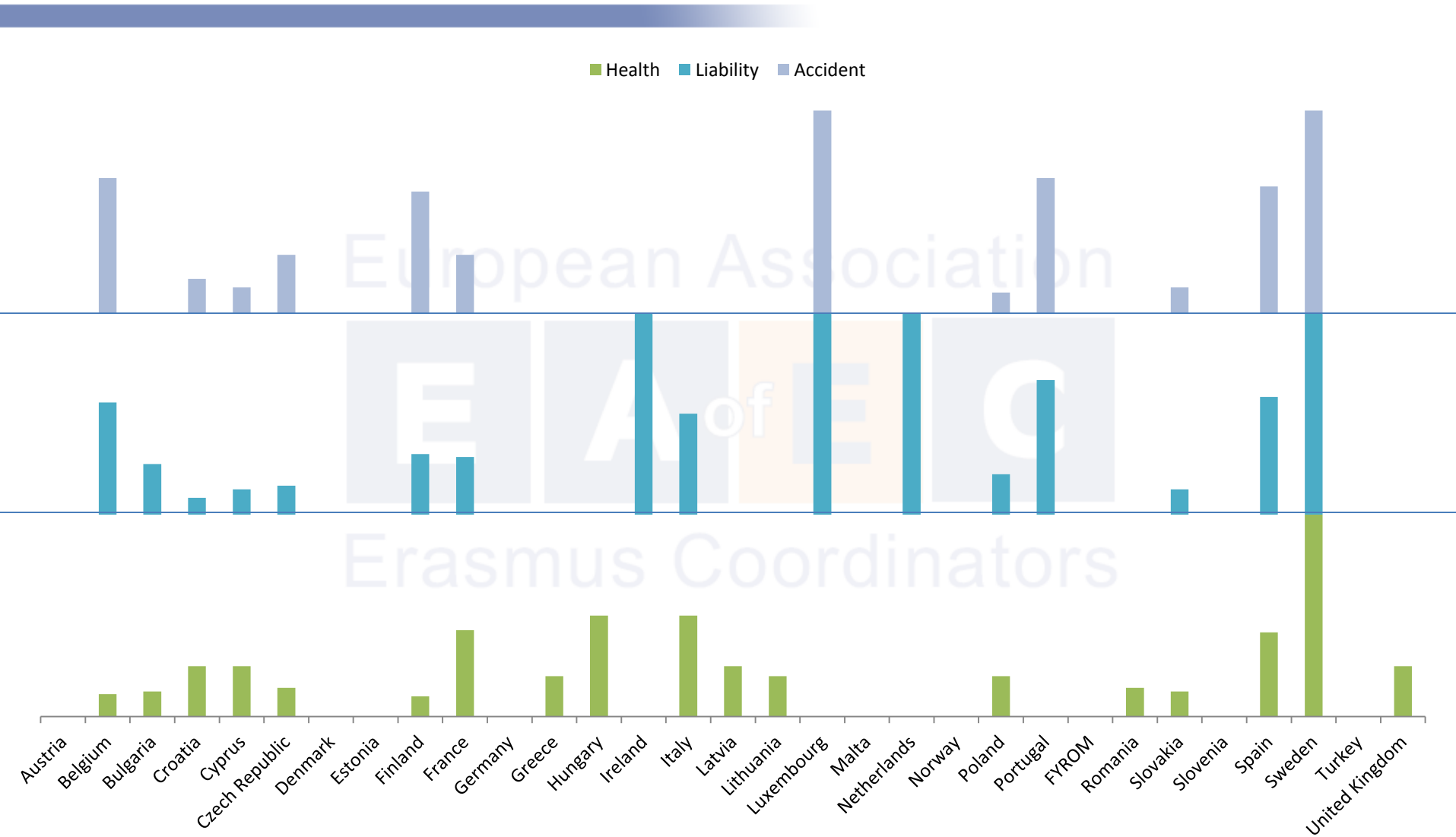

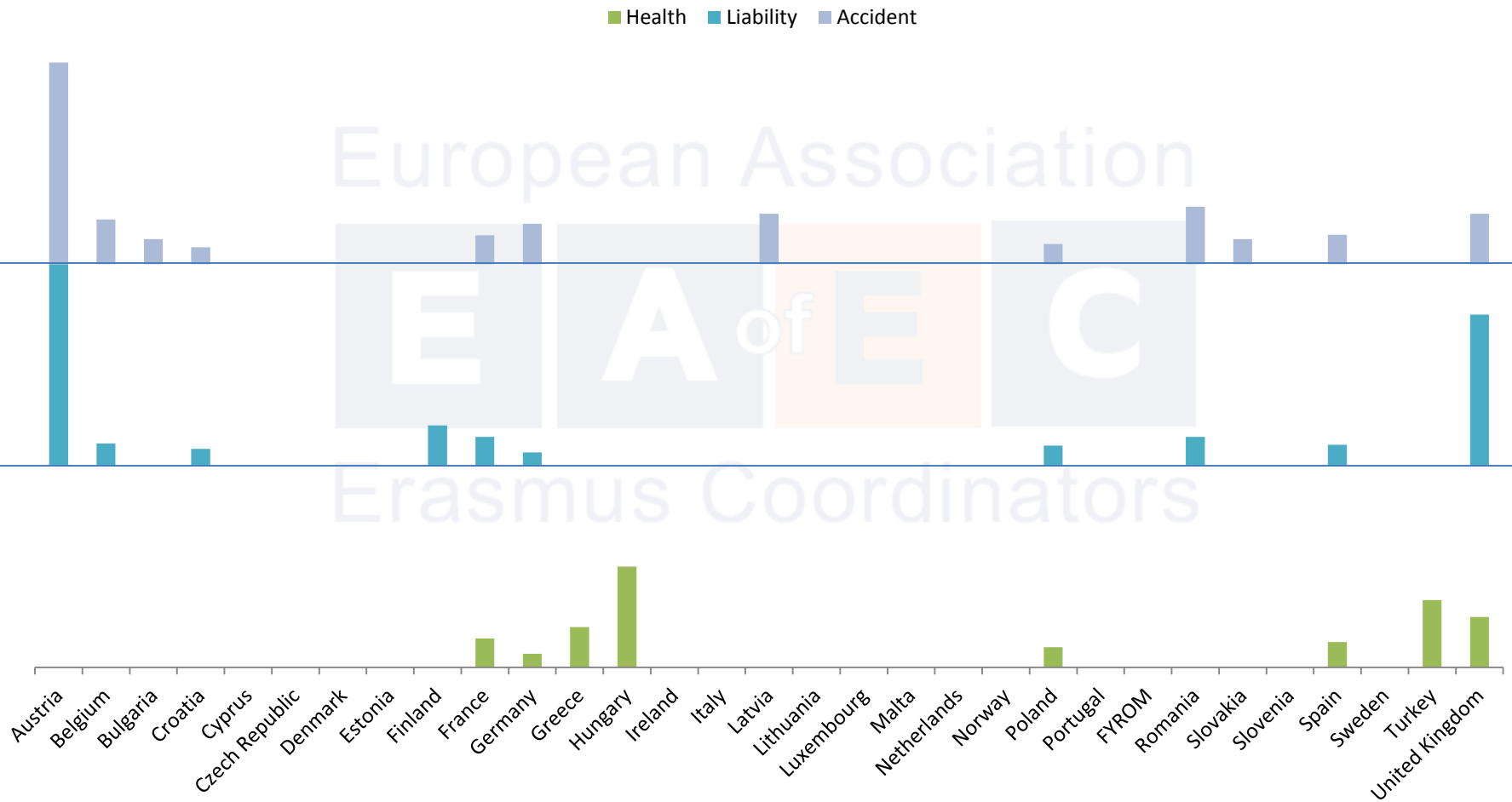
What type of insurance do students most often taking care of (Question 7)



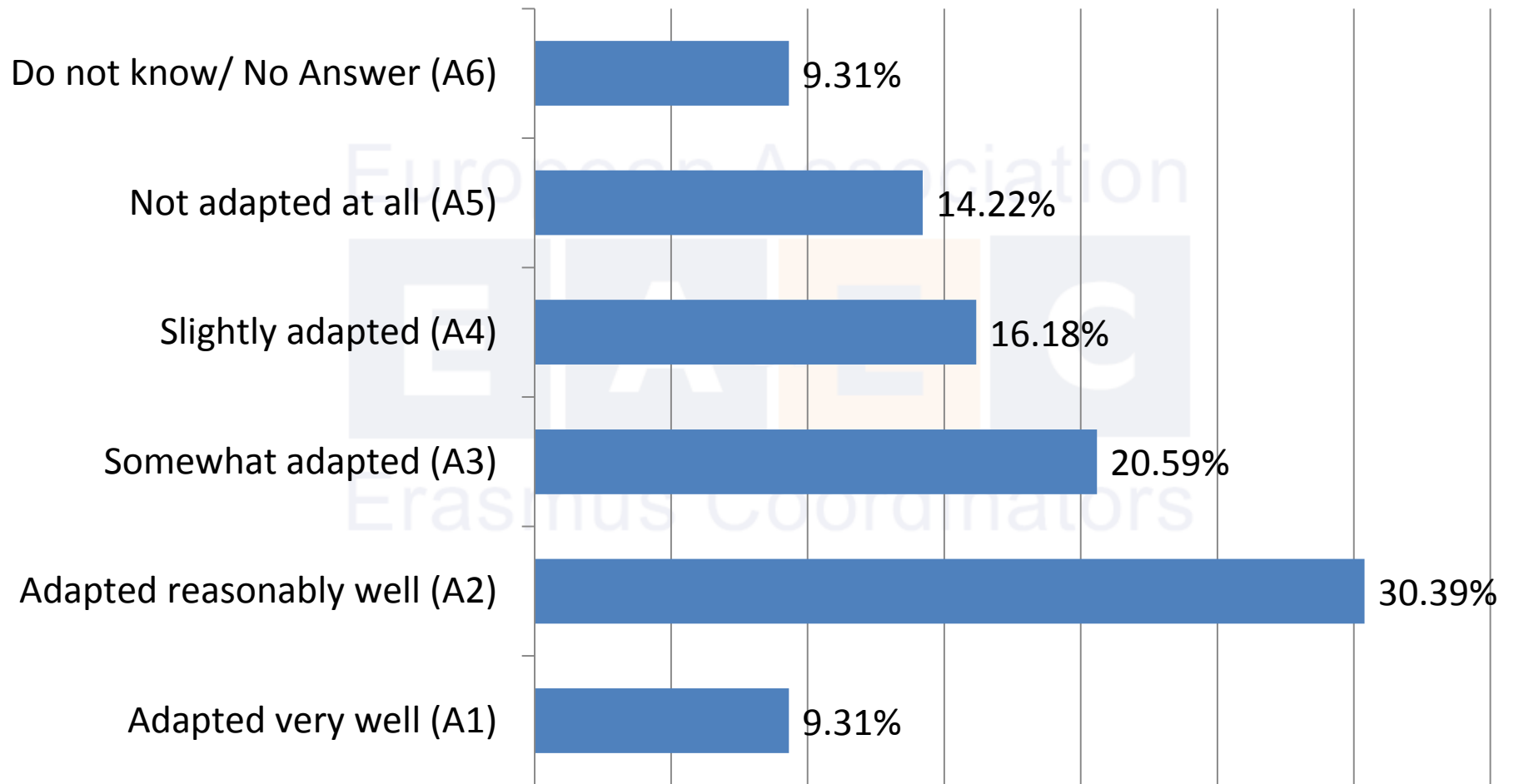
What type of insurance do sending HEIs most often taking care of (Question 7)



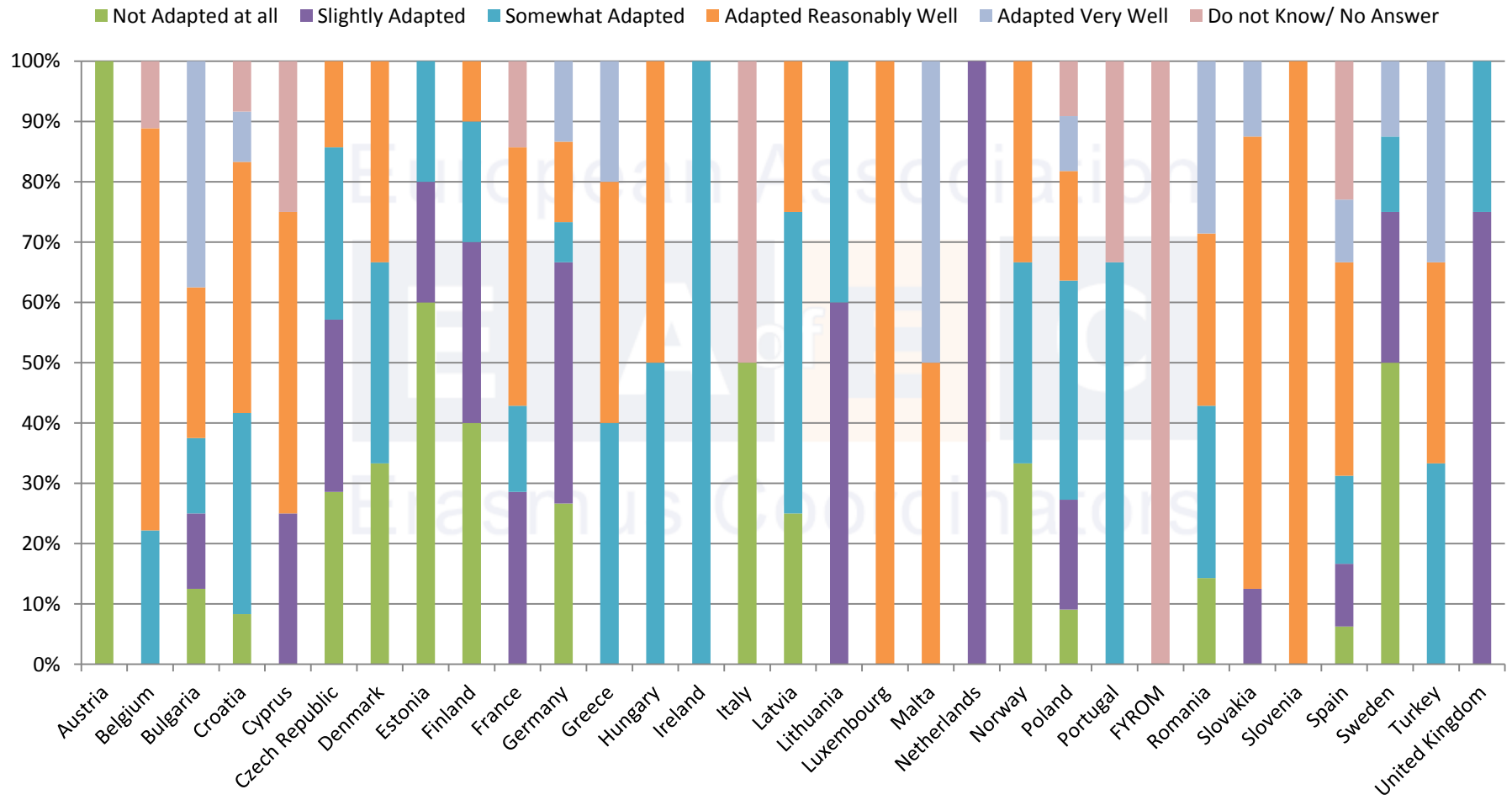
What type of insurance do receiving organizations most often taking care of (Question 7)



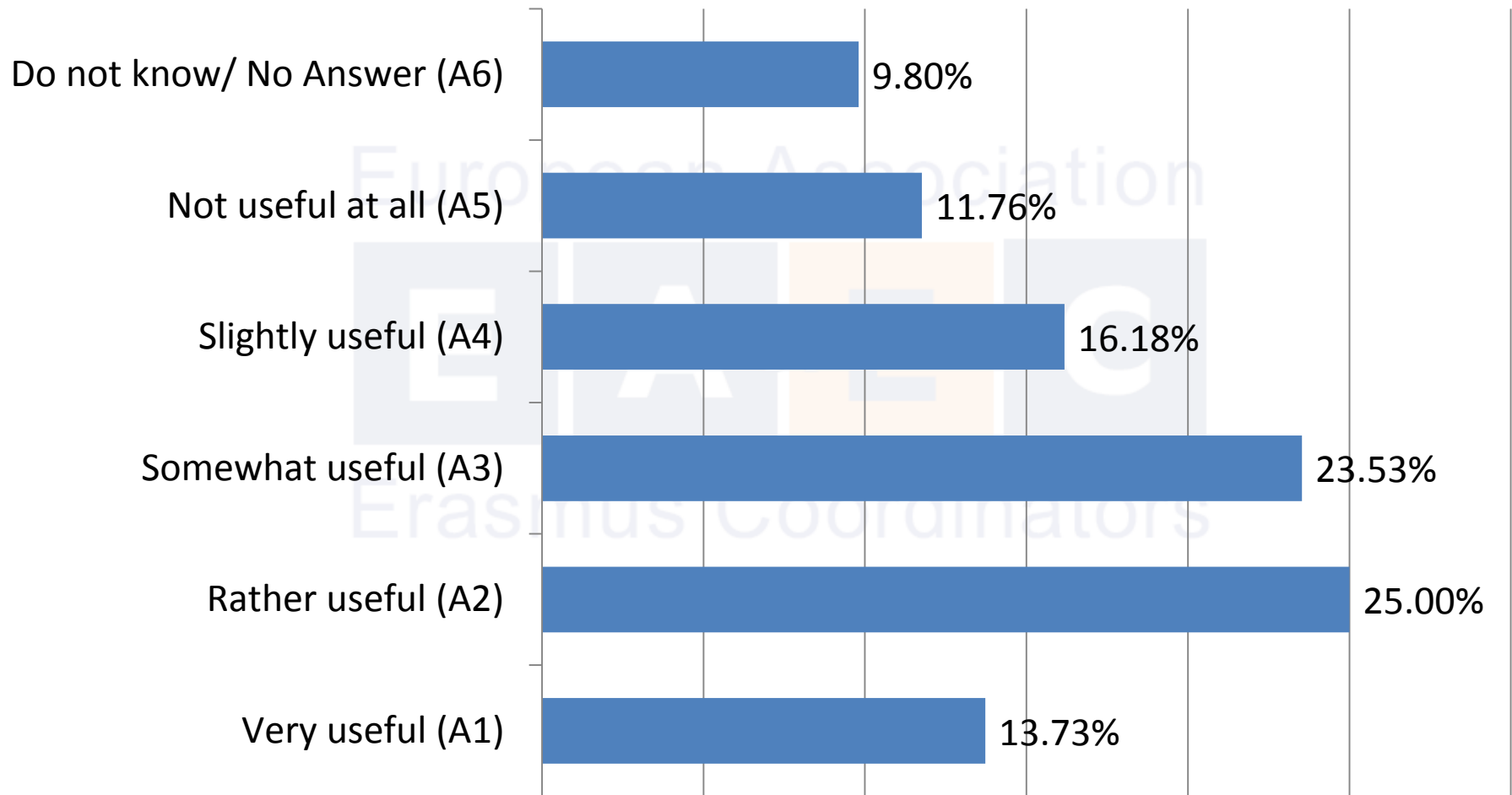
Q8.To which extent is the Mobility Tool adapted to your needs in terms of monitoring your mobilities?



Adaptation of the Mobility Tool to the needs in terms of monitoring mobilities (Question 8)

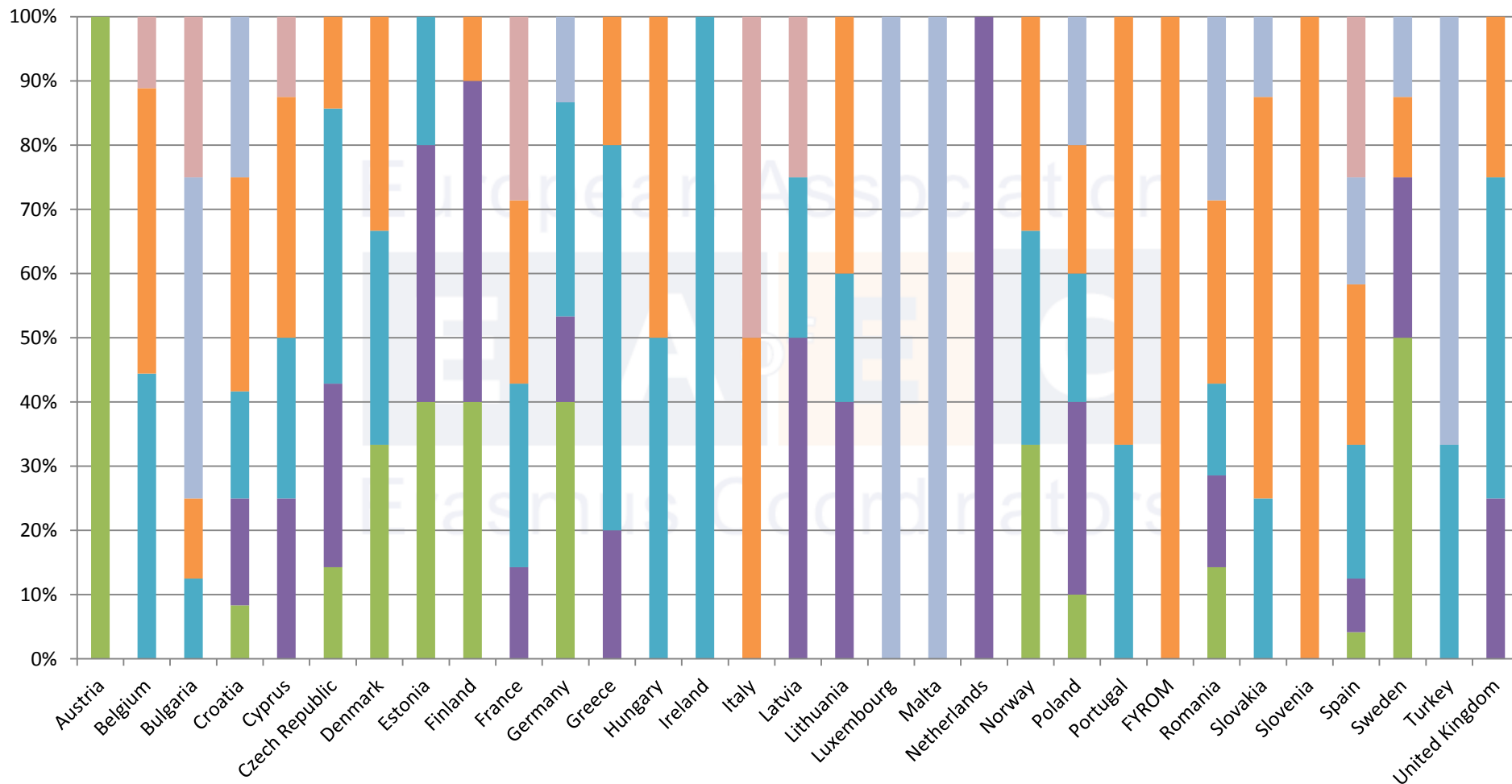

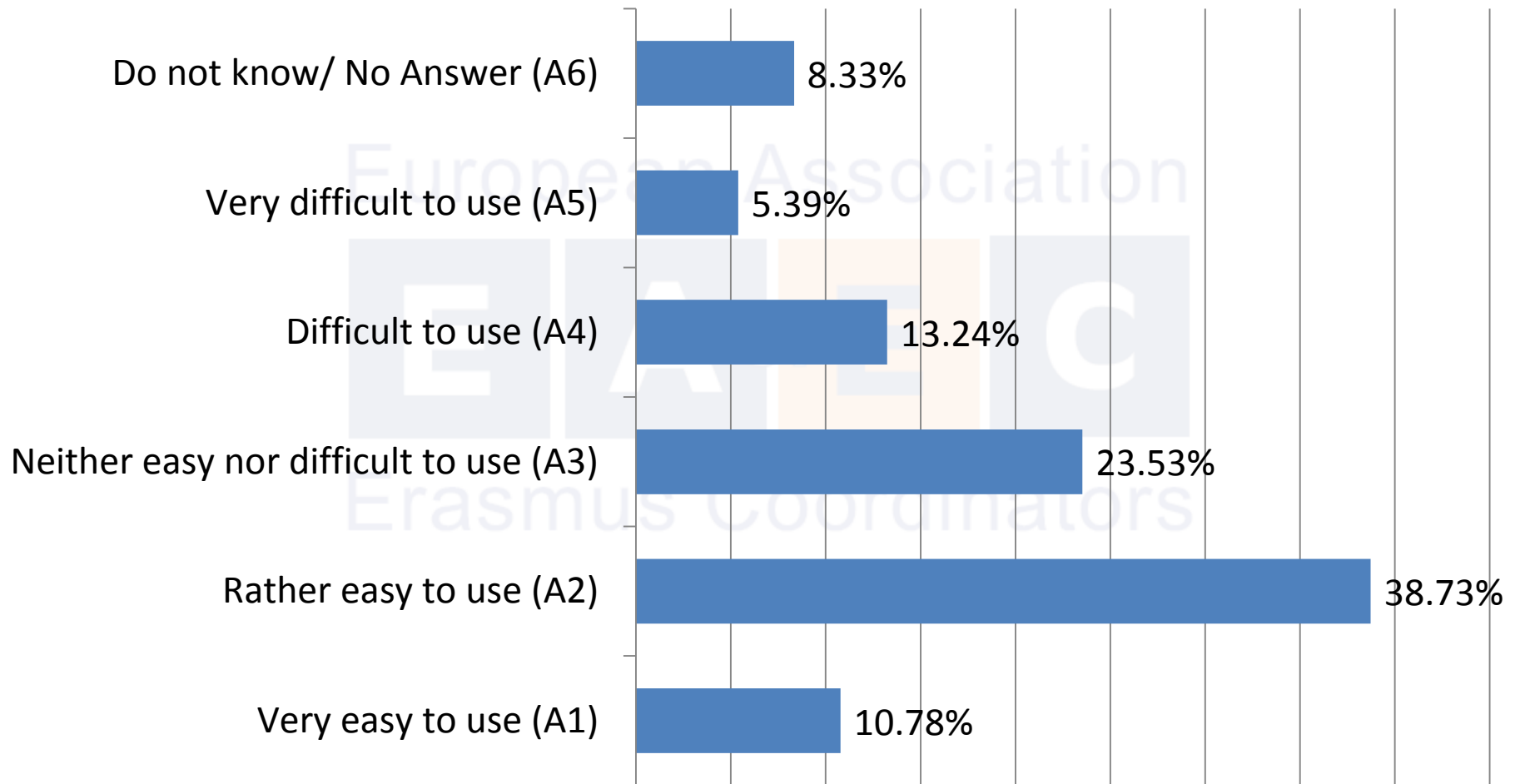


How useful is the Mobility Tool per country (Question 9)

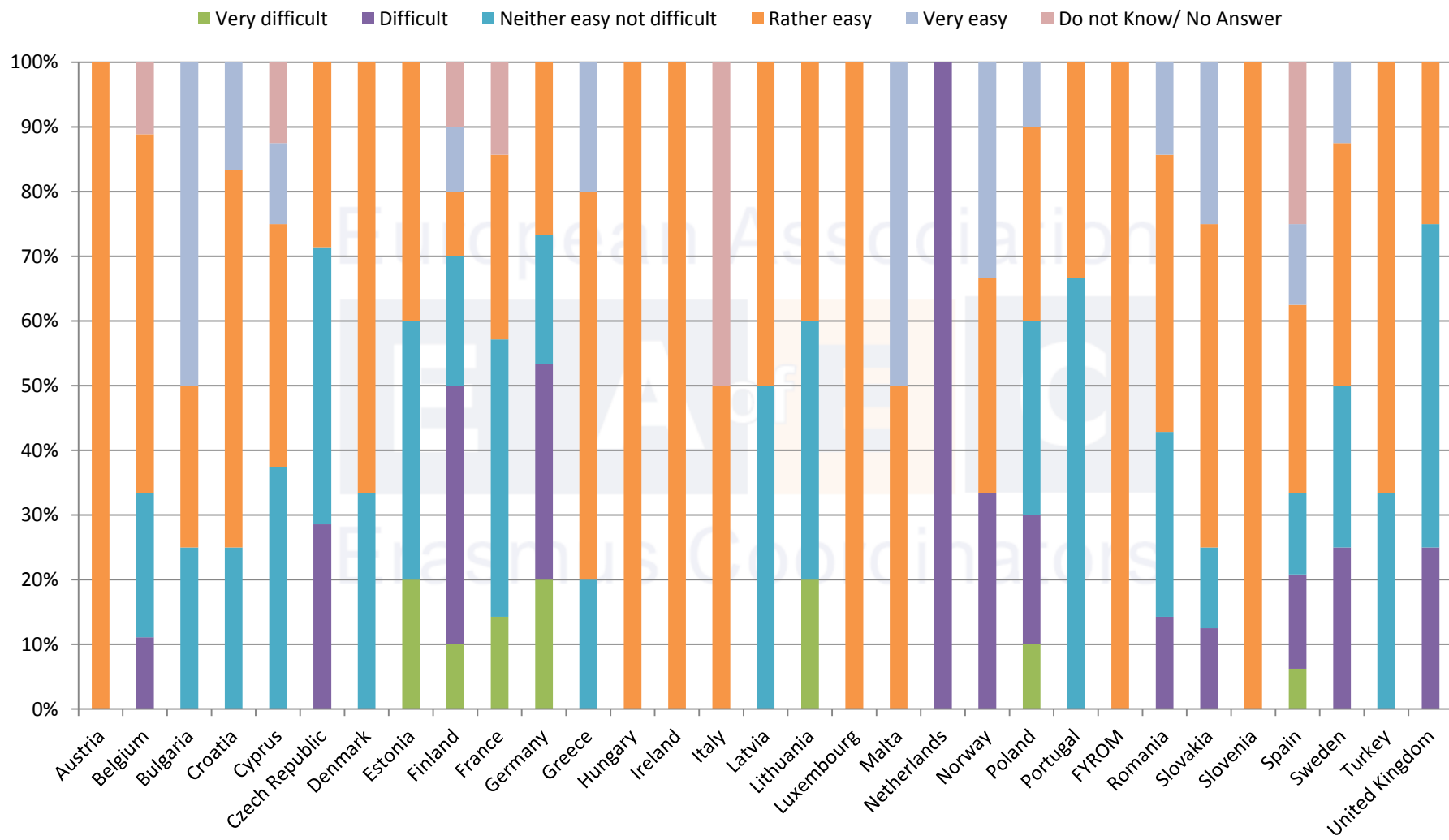

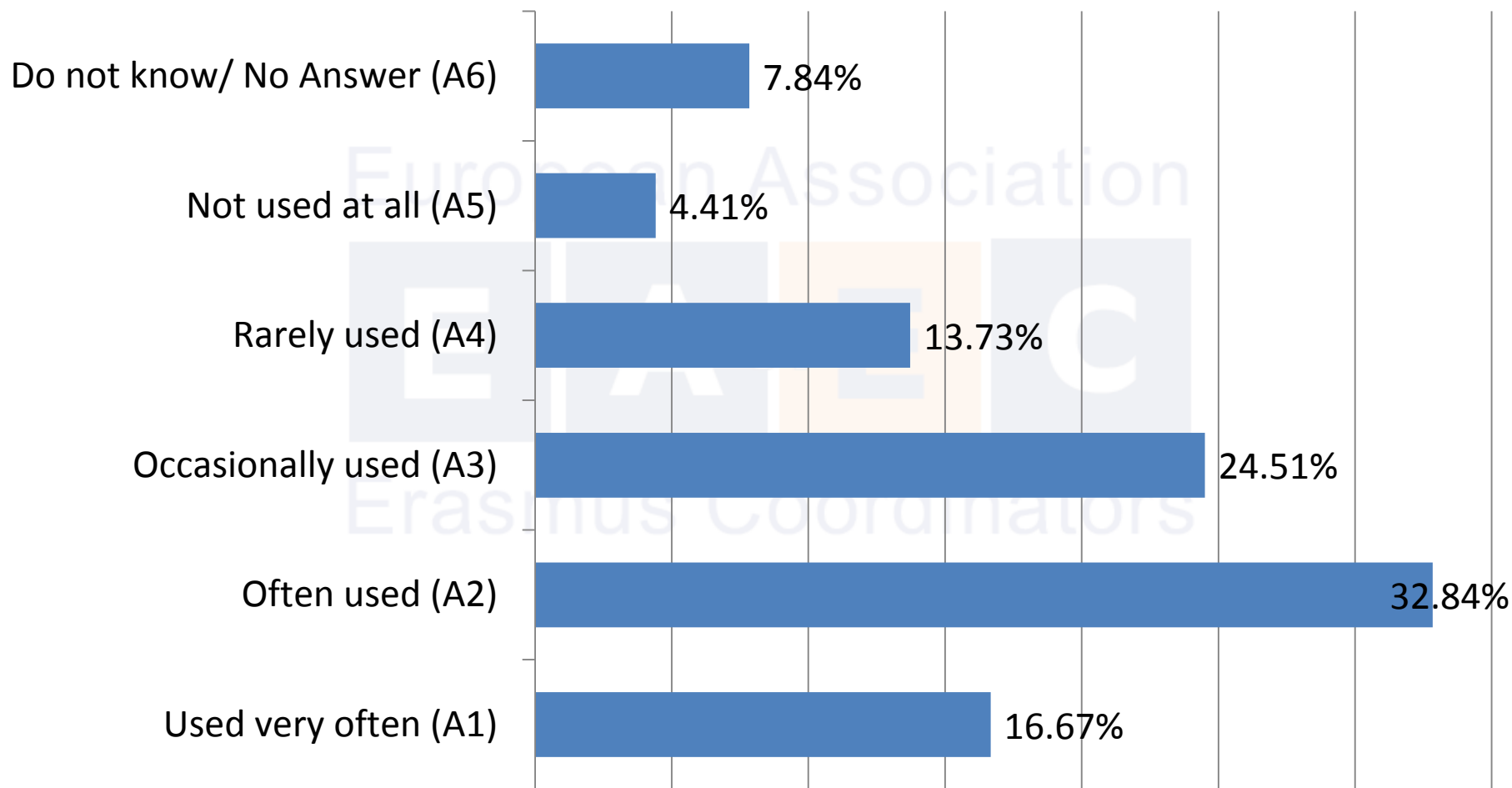

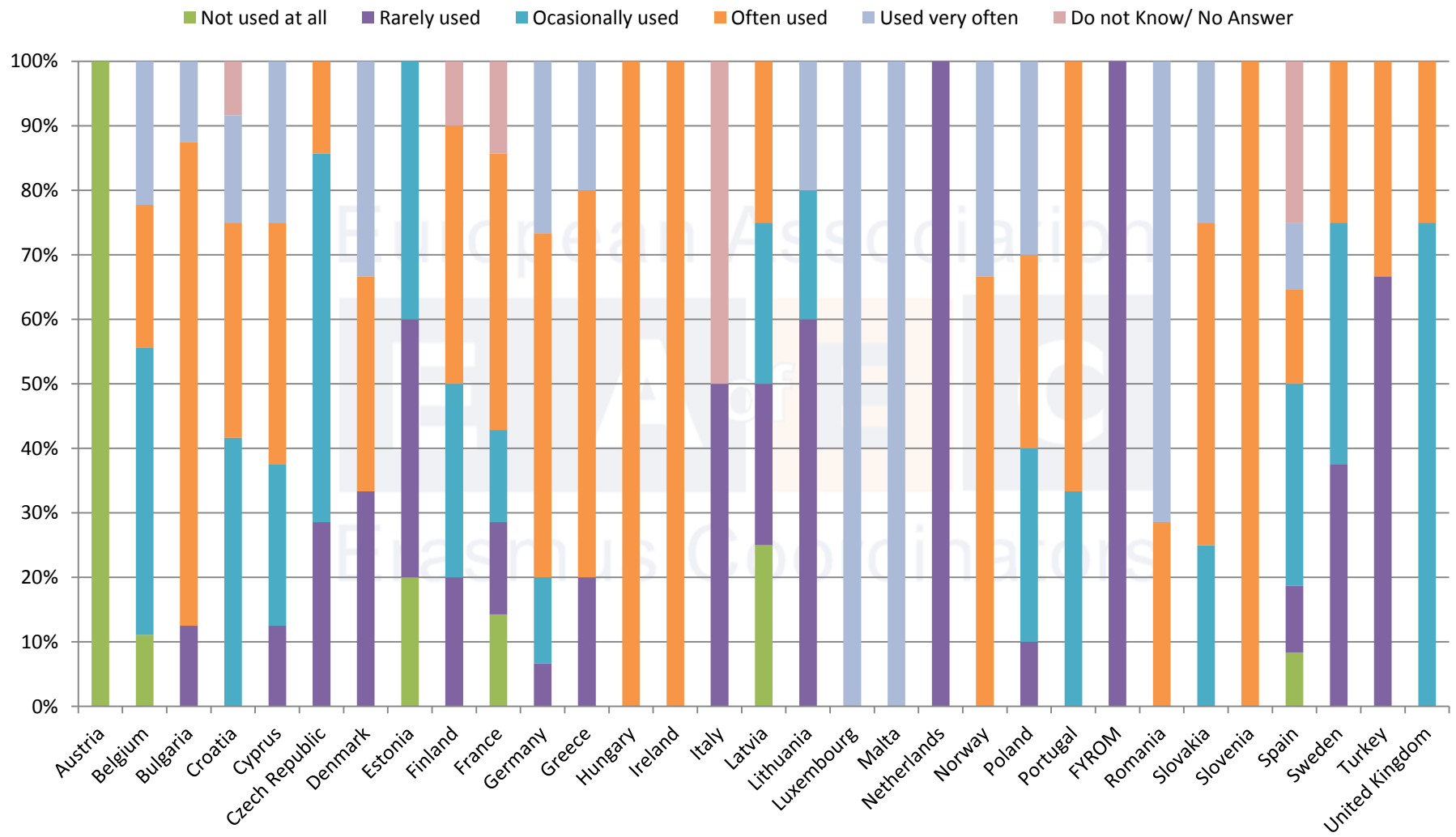
How easy to use is the Mobility Tool per country (Question 10)



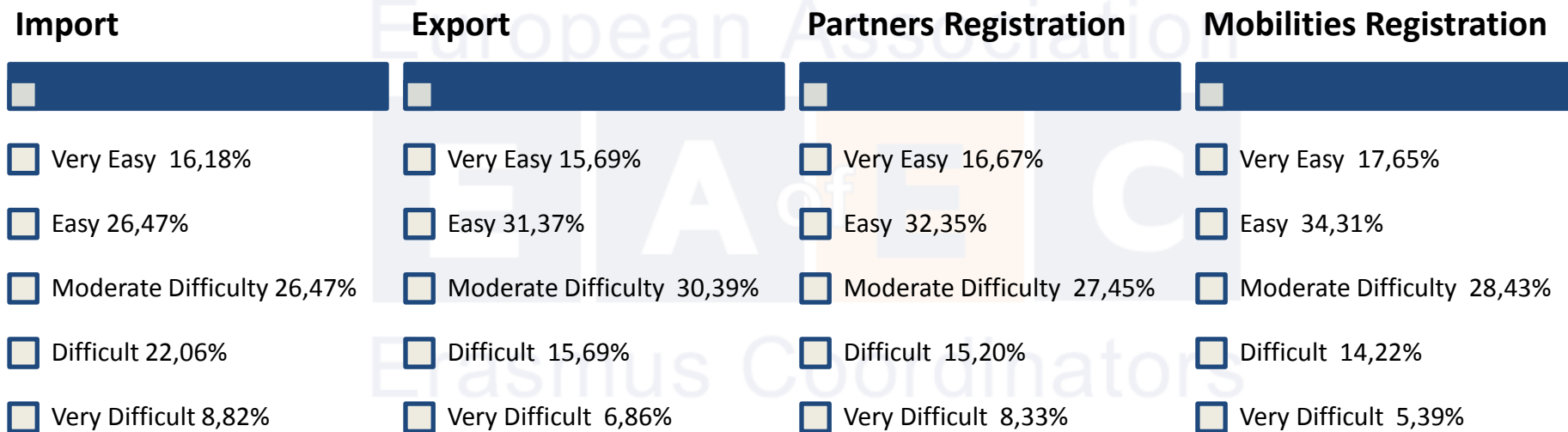
Q11. Is the Mobility Tool used at your institution on a regular basis?



How often is the Mobility Tool used per country (Question 11)

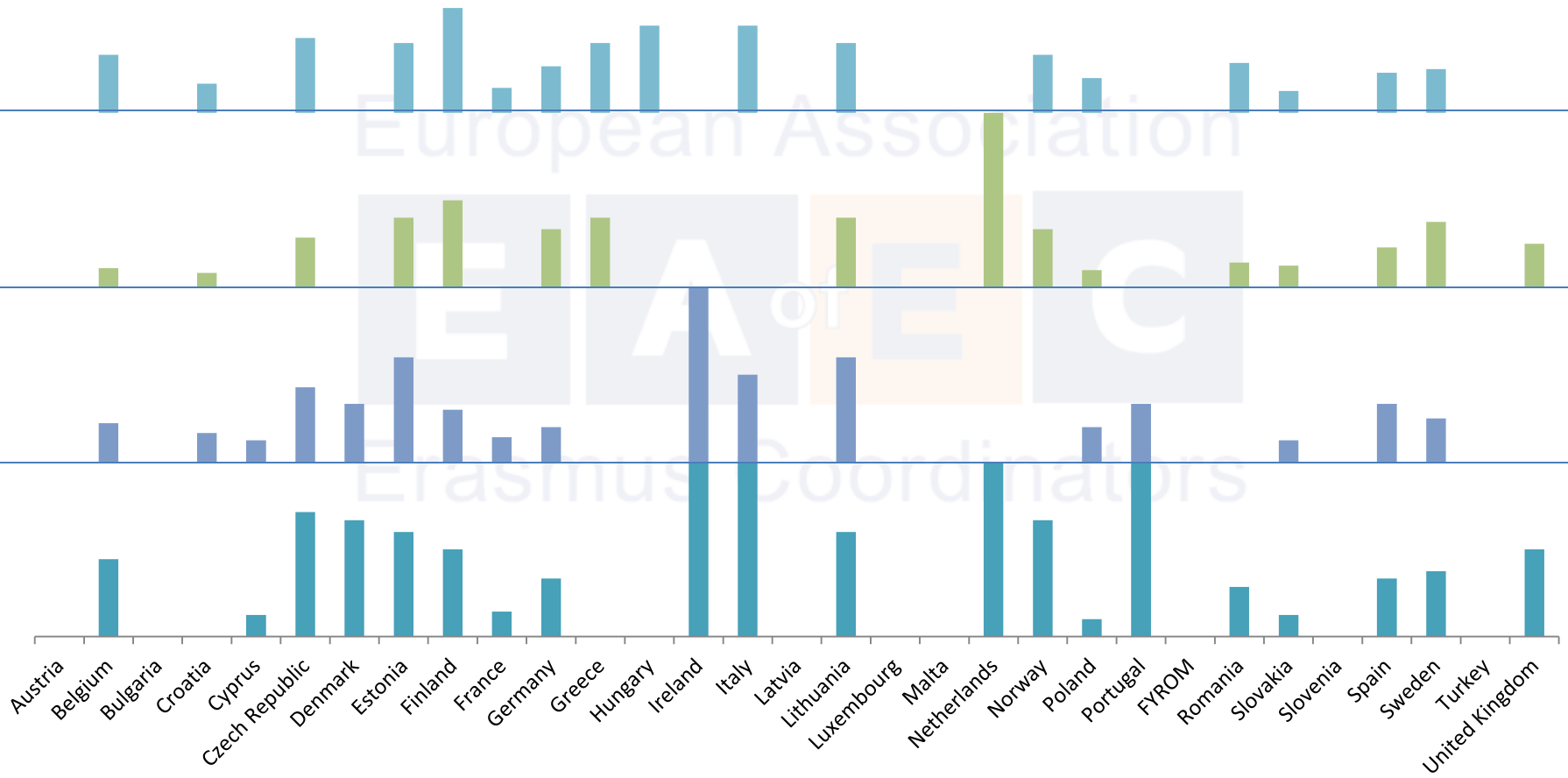


Q12. Among the following features of the Mobility Tool, rate their level of difficulty:

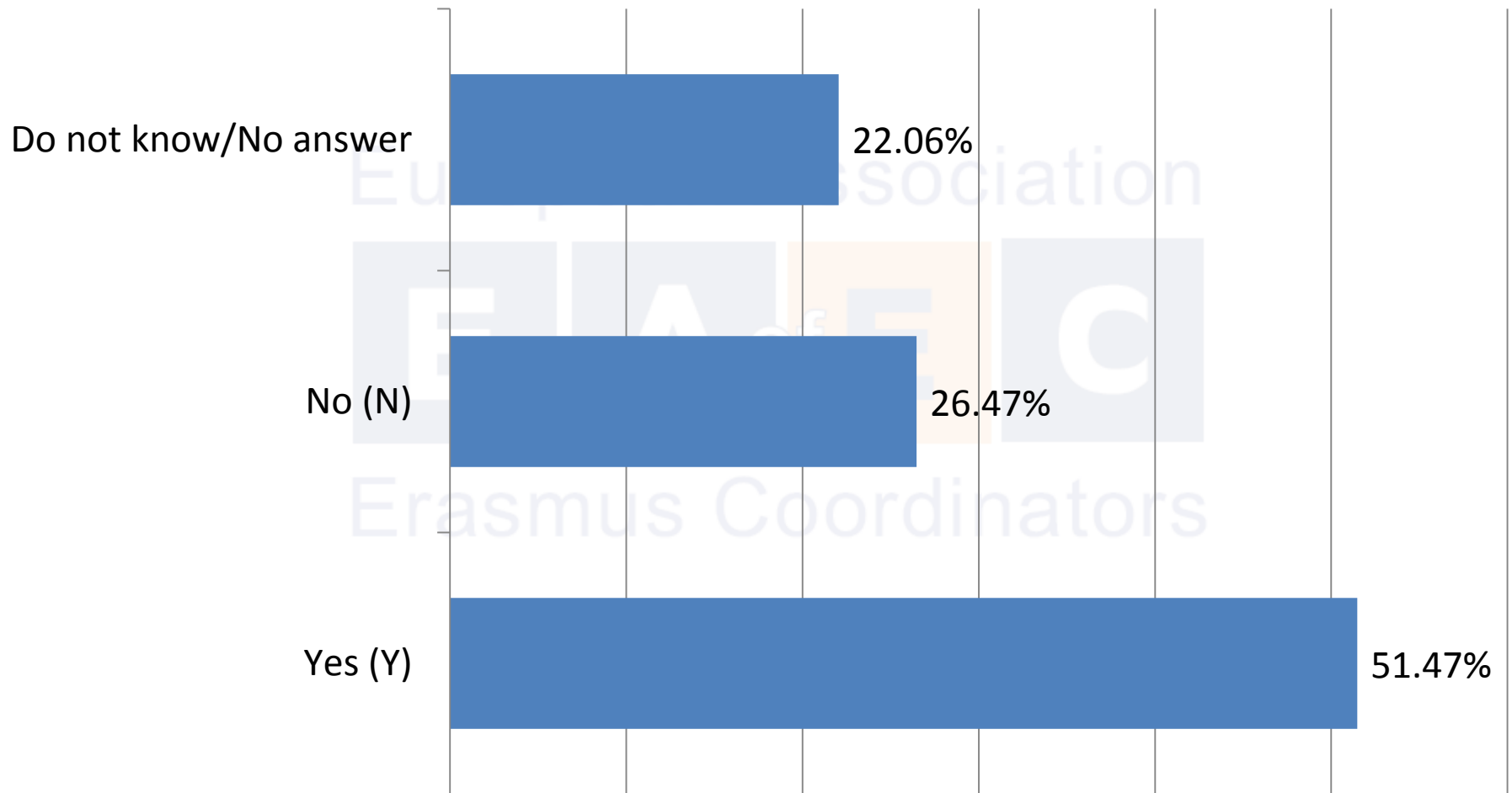

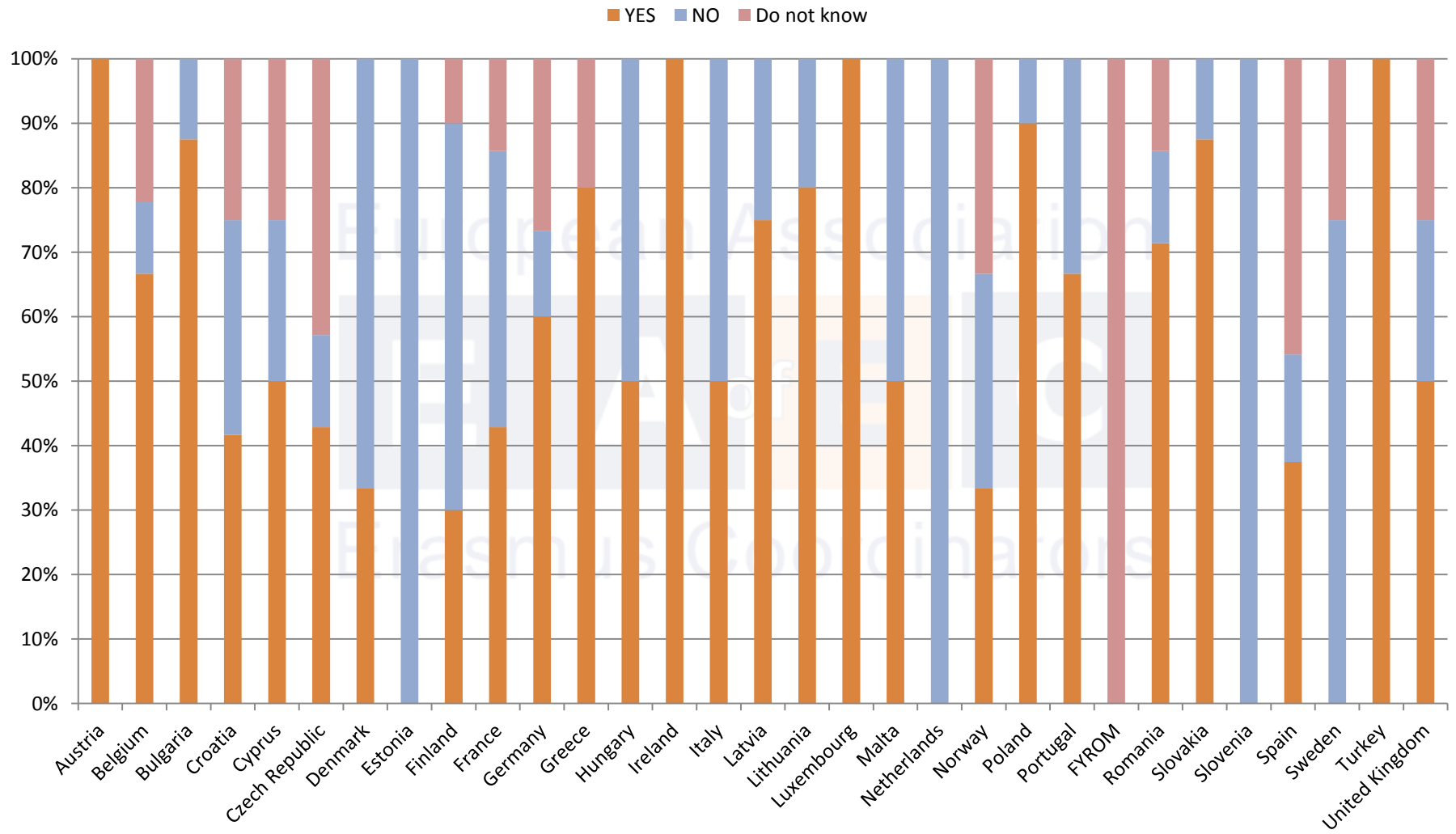

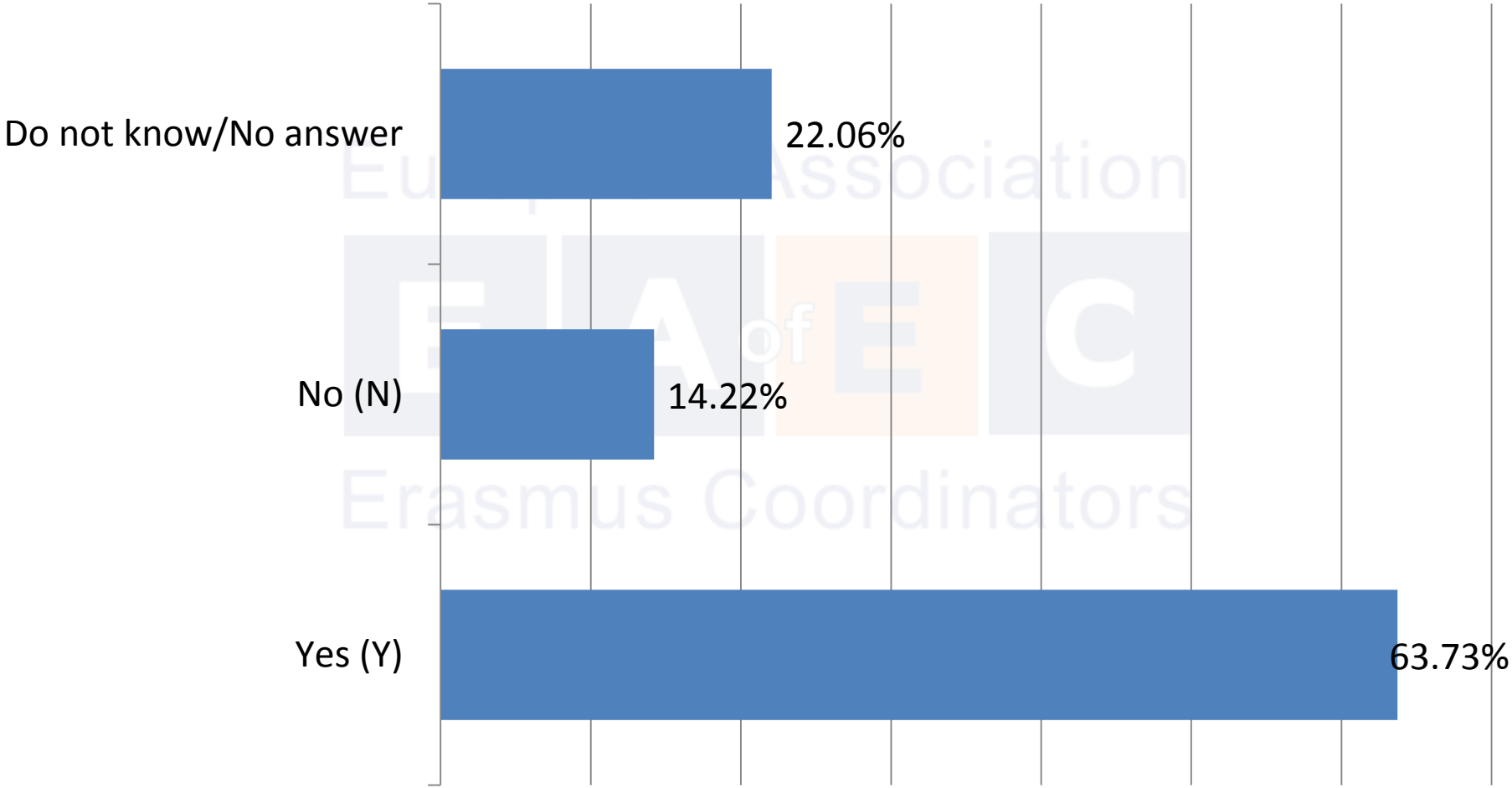

Has your institution published the specific deadlines for students to introduce changes in the Learning Agreement? Per Country (Question 13)

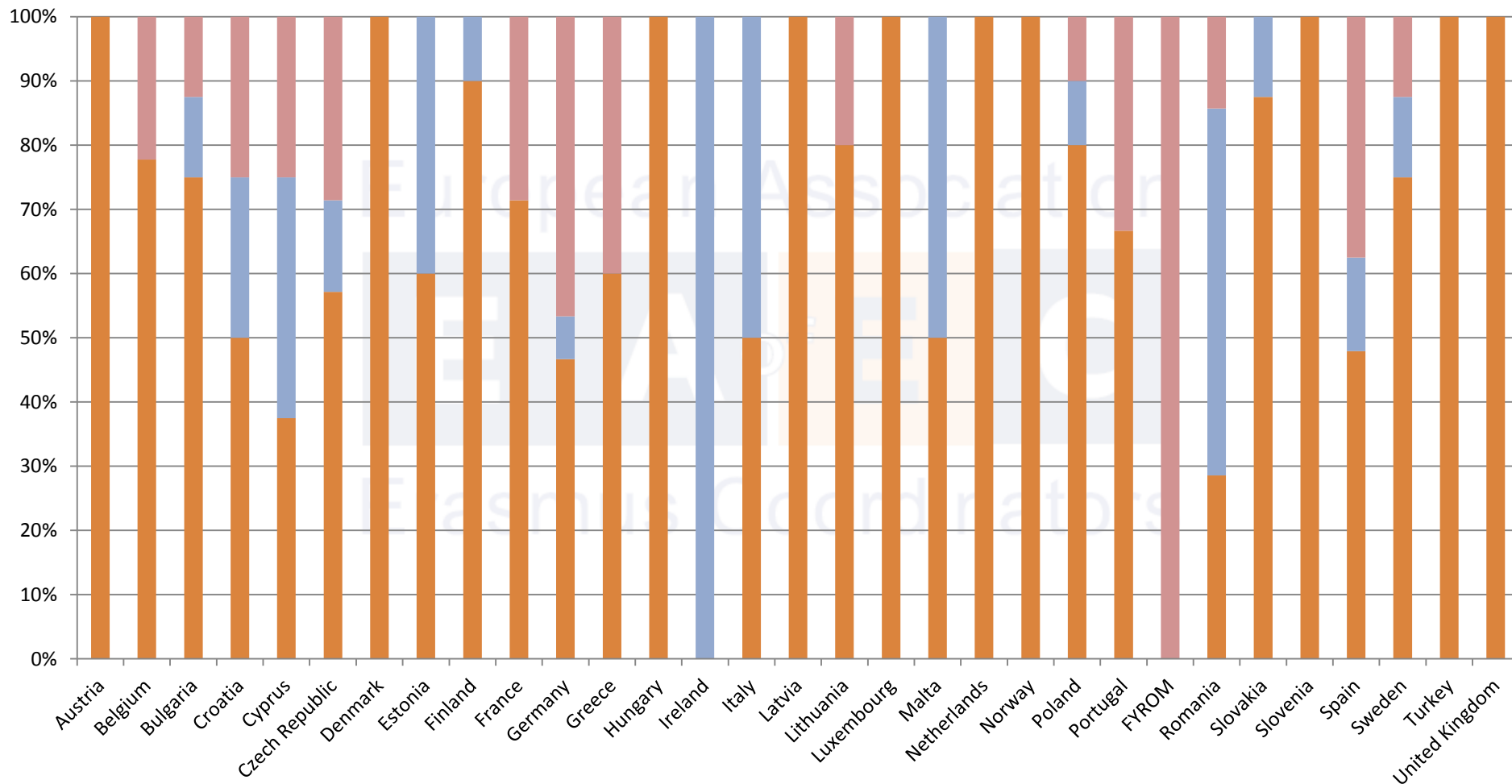


Q14. Did your institution managed to update its course catalogue before the end of the previous academic year?

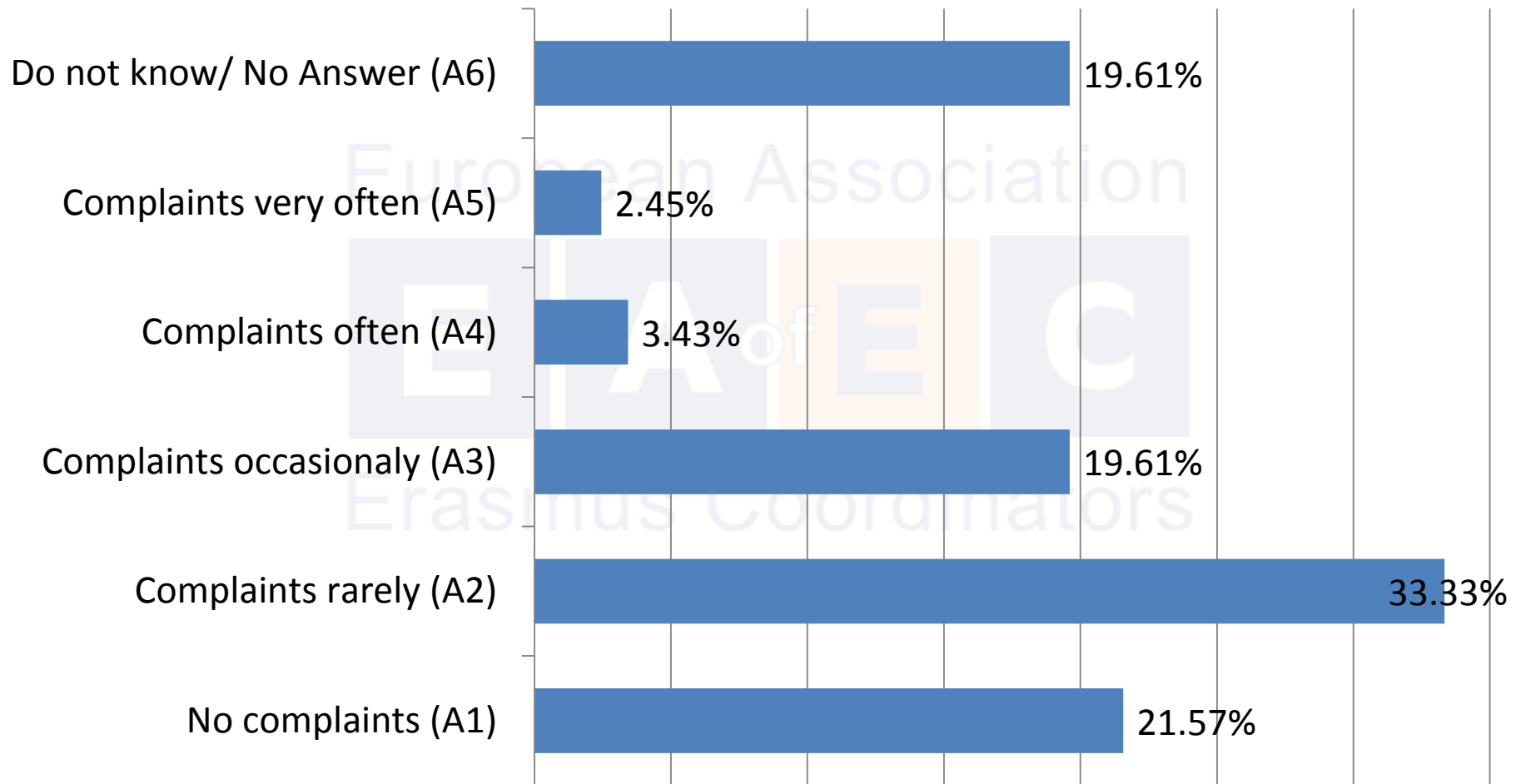


Did your institution managed to update its course catalogue before the end of the previous academic year? Per Country (Question 14)

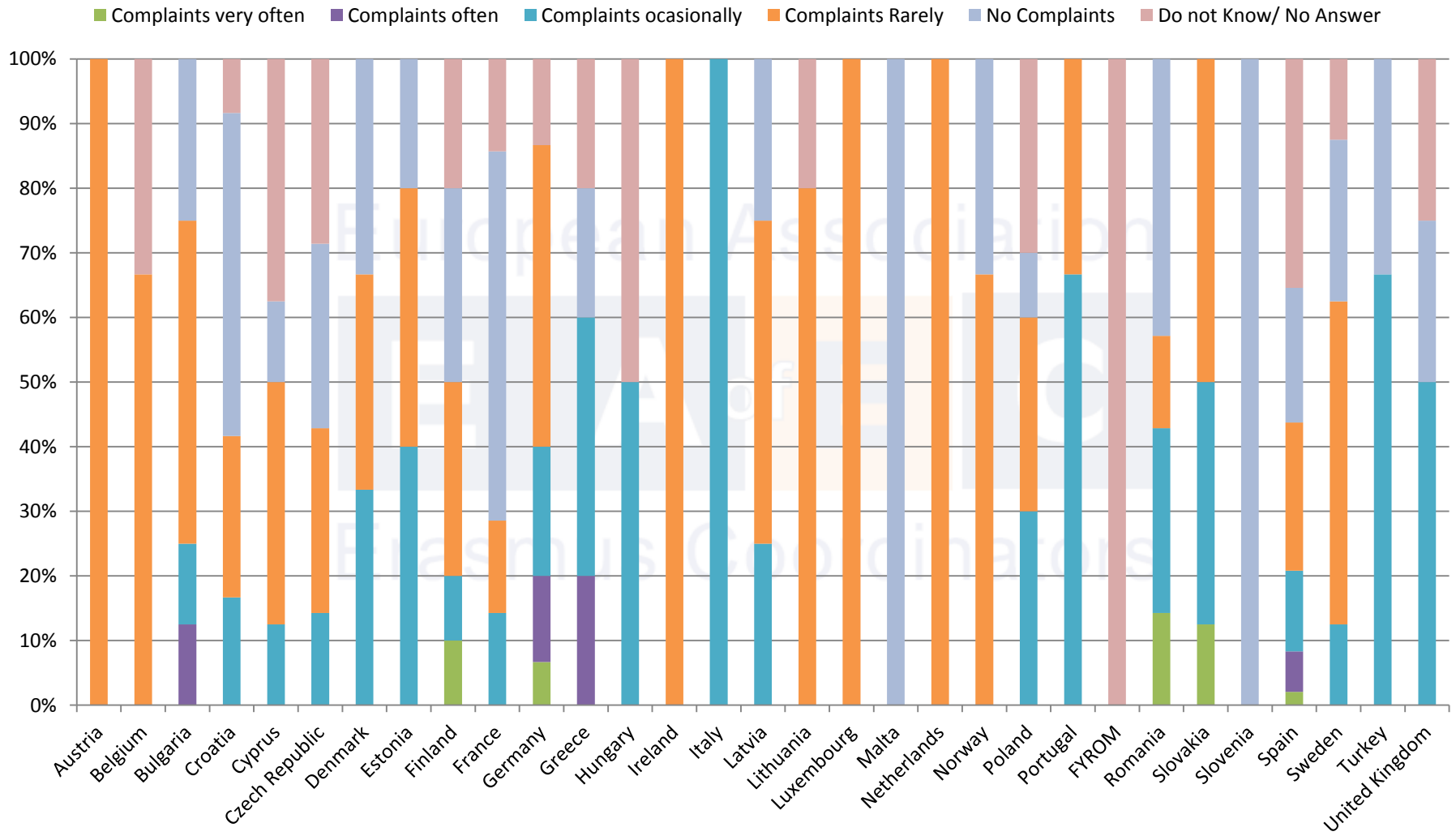

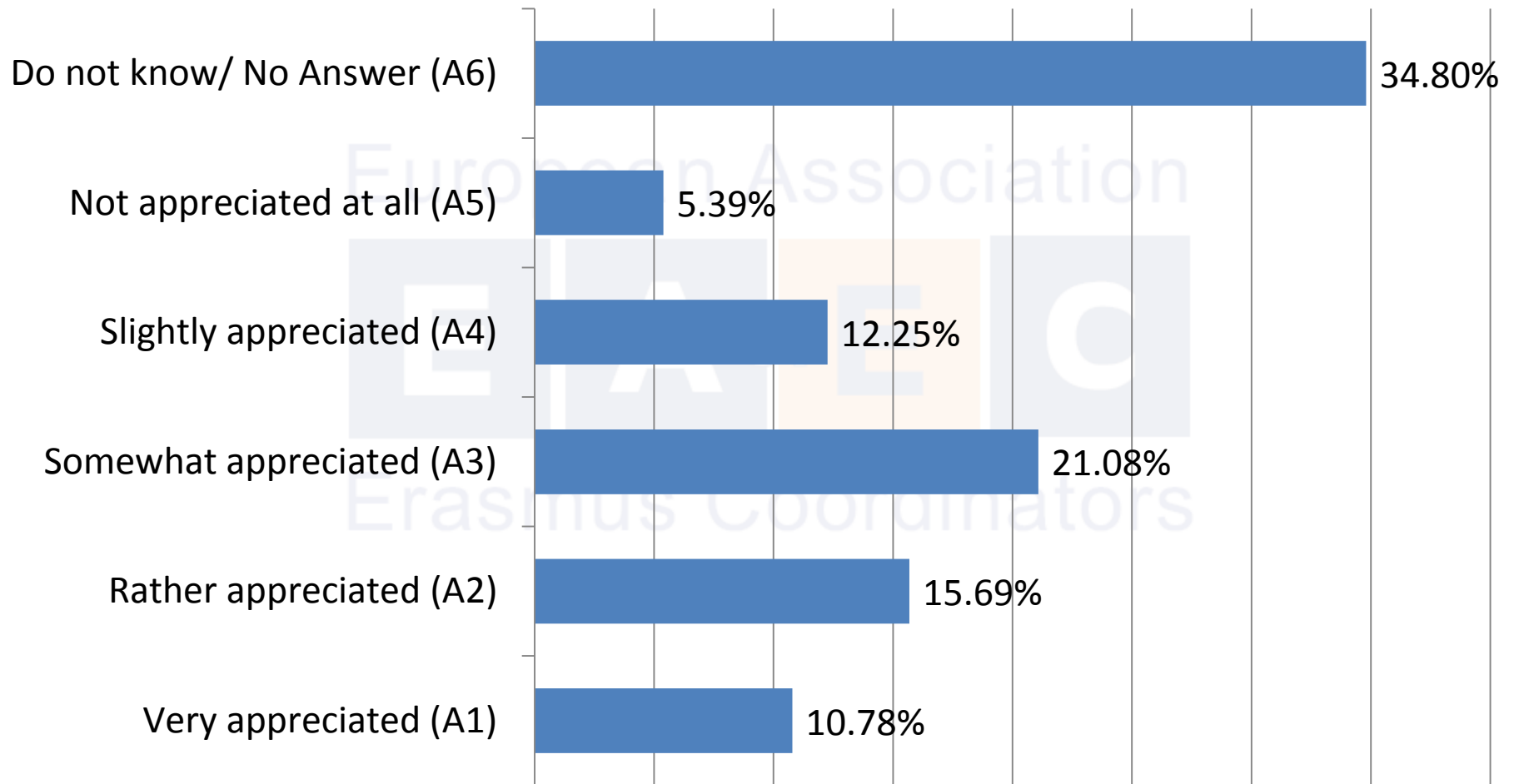

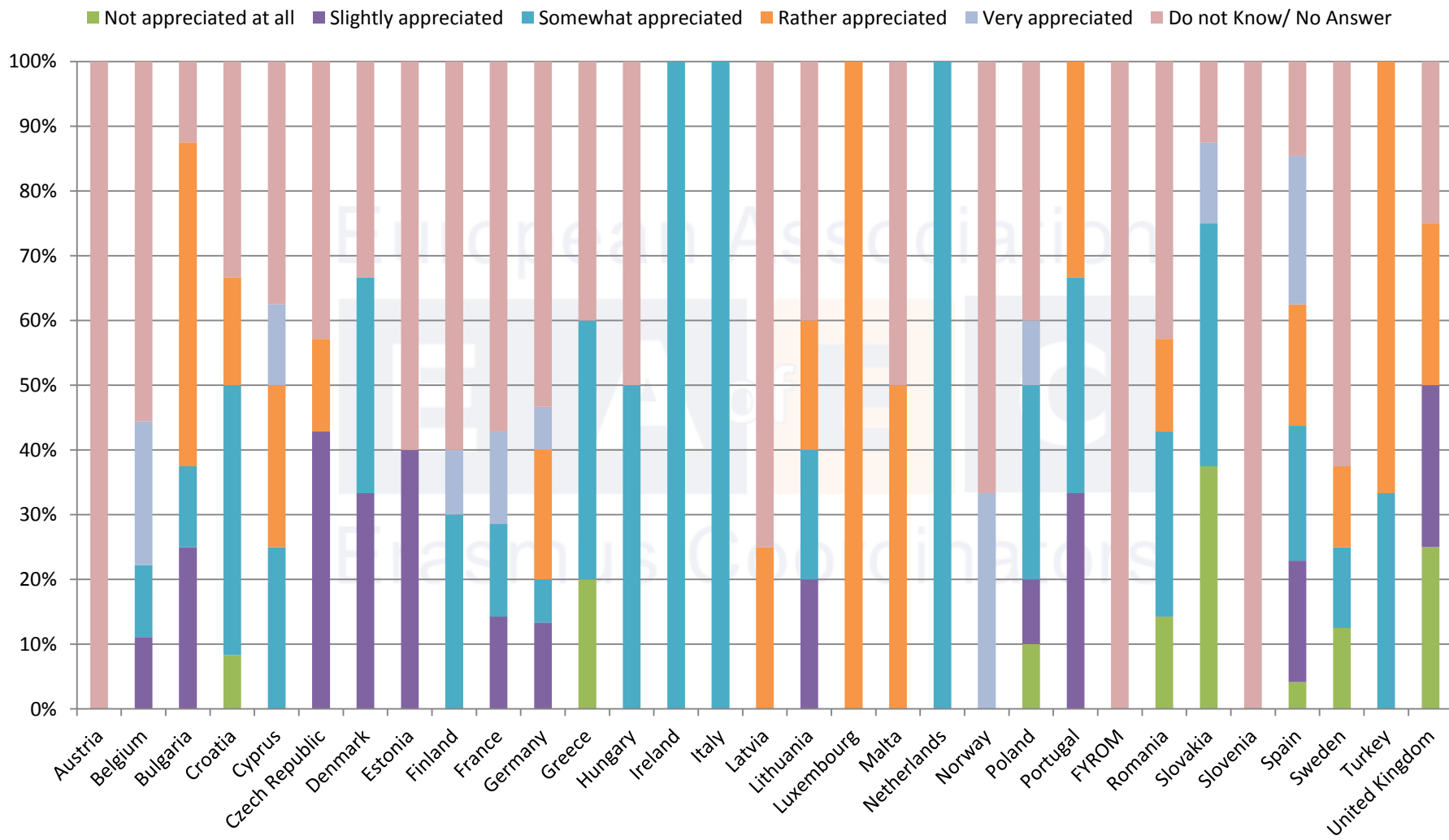
To which extend do you think the new Learning Agreement will avoid complaints from students regarding the recognition of their programme abroad? Per country (Question 15)

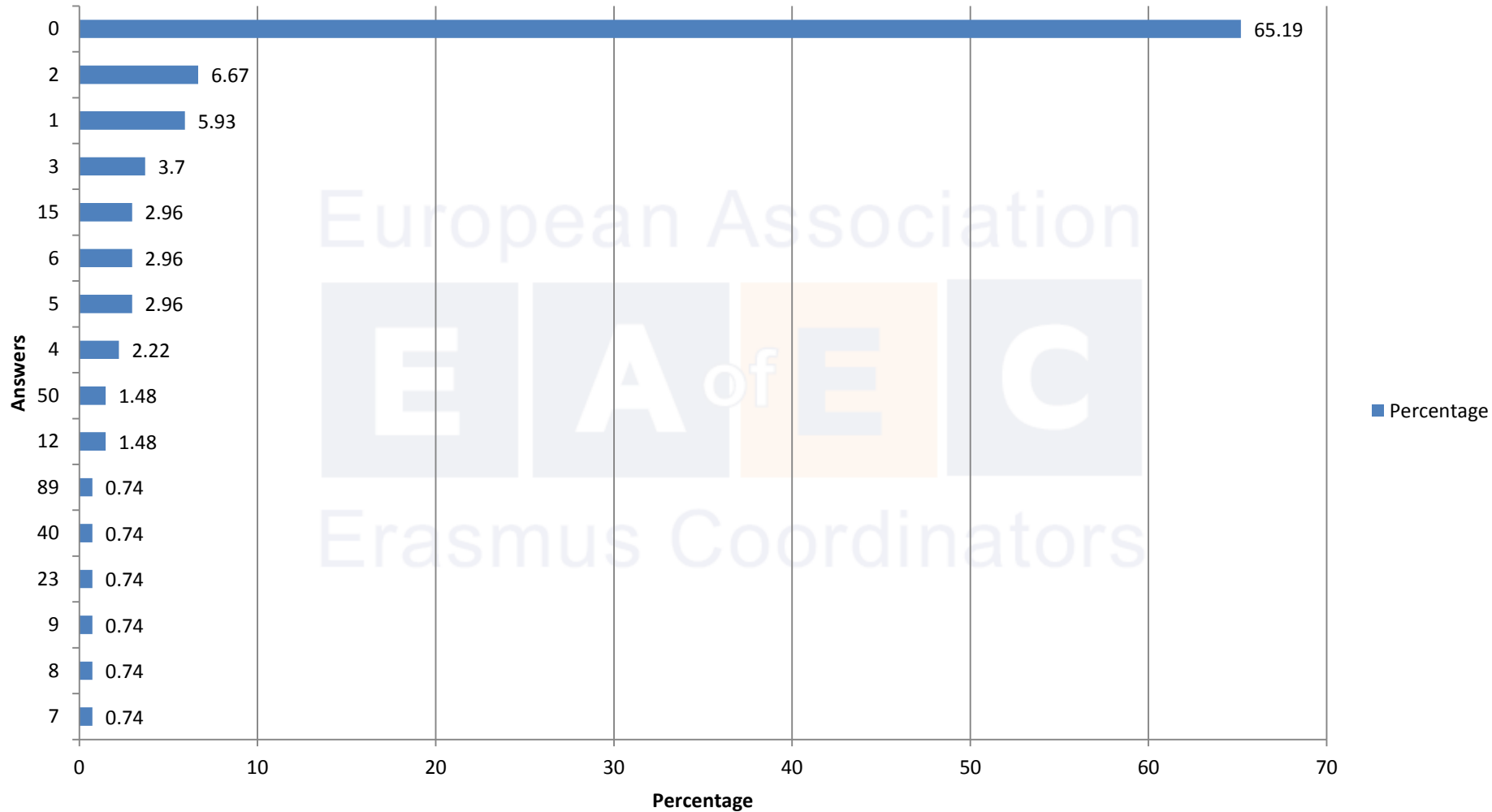

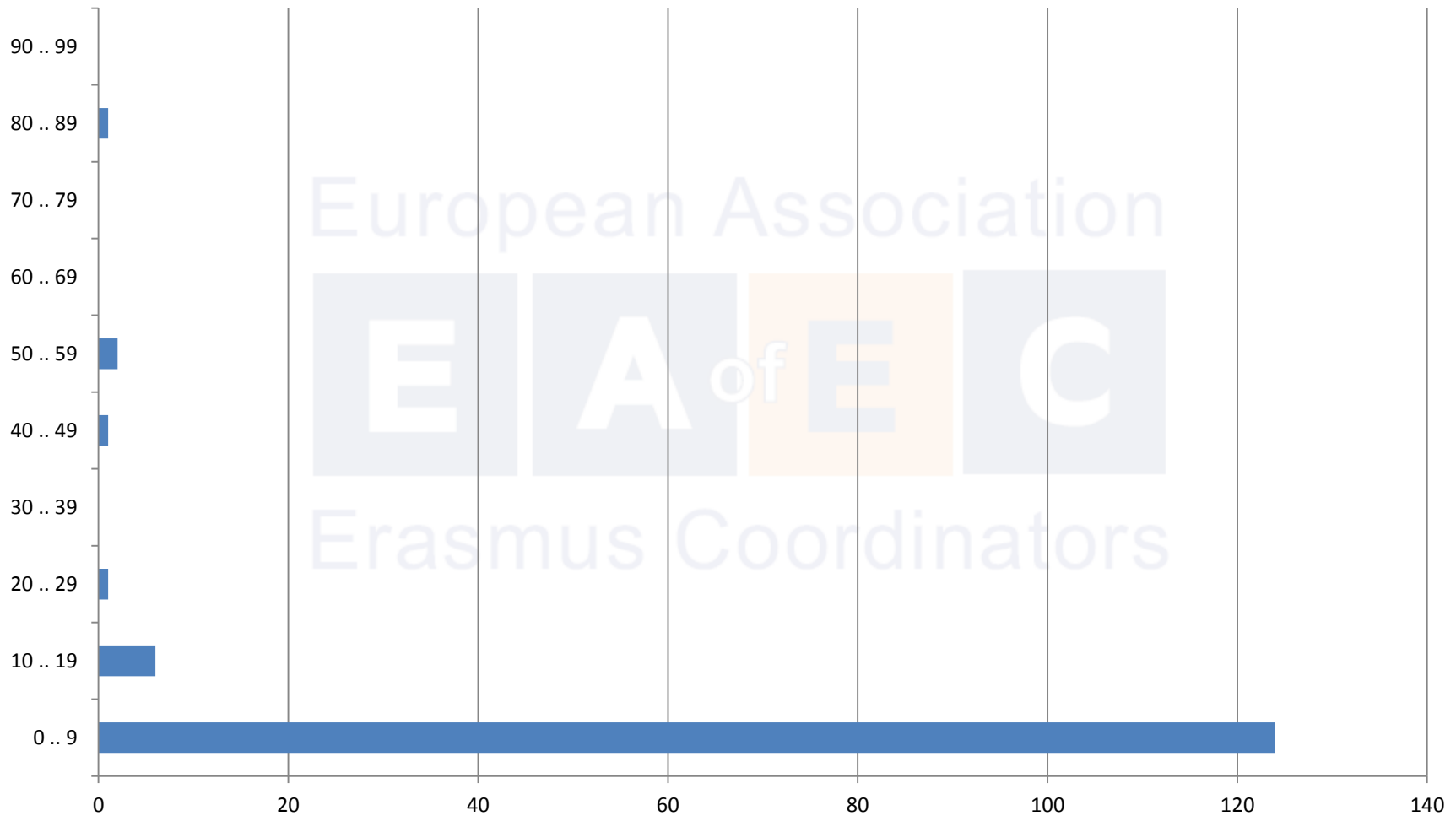

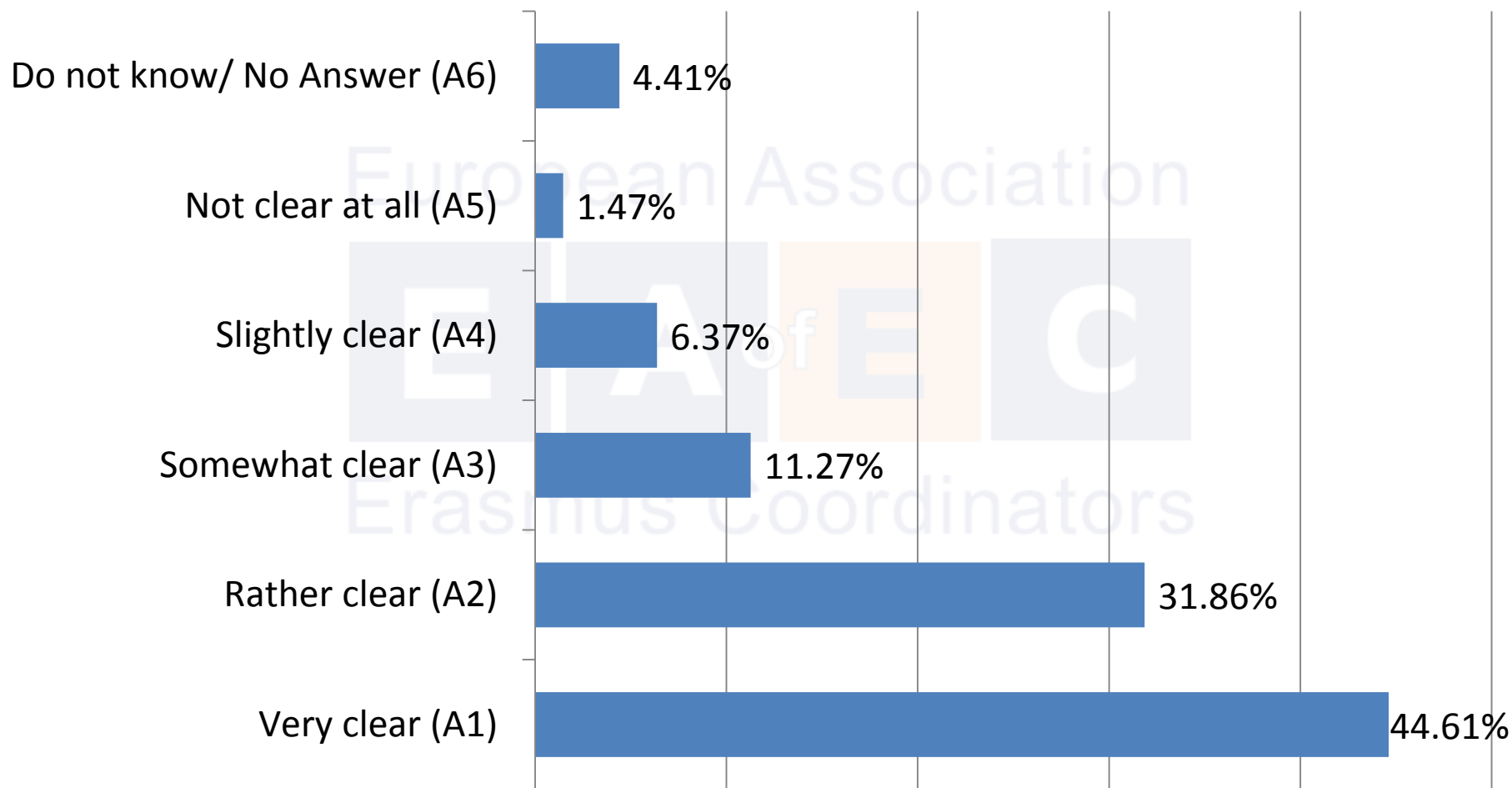

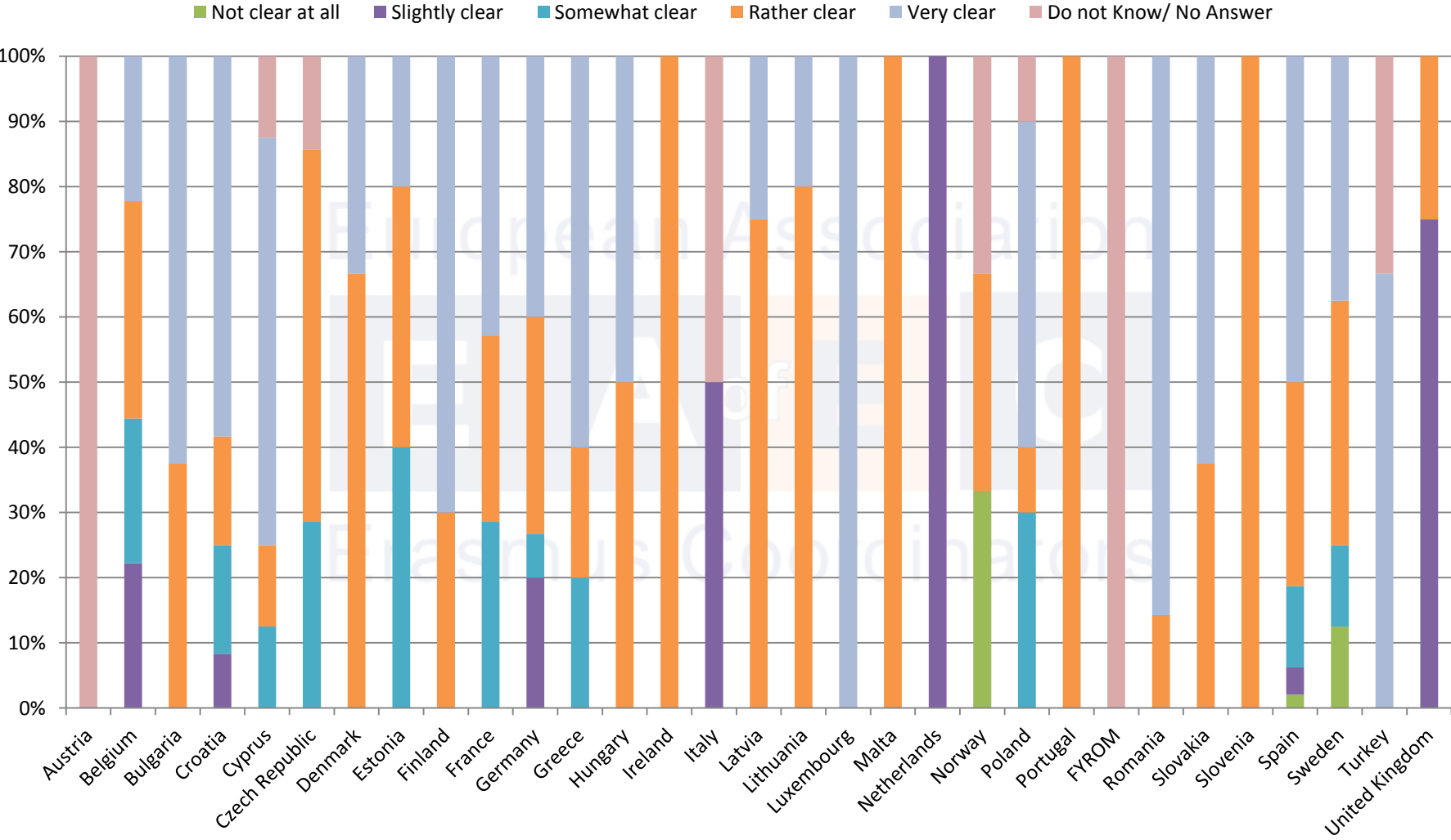

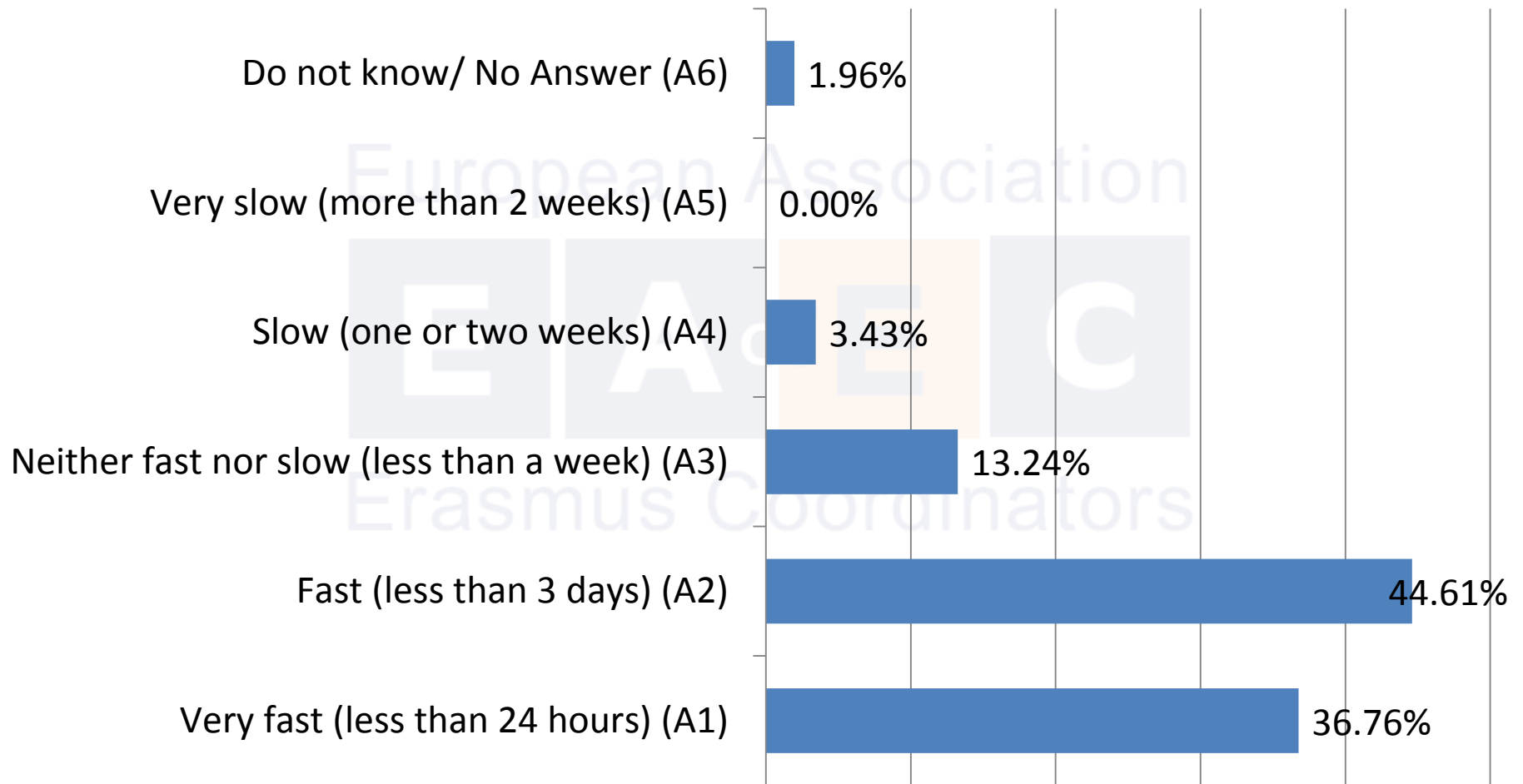
Q18. Do you get clear responses from your National Agency?



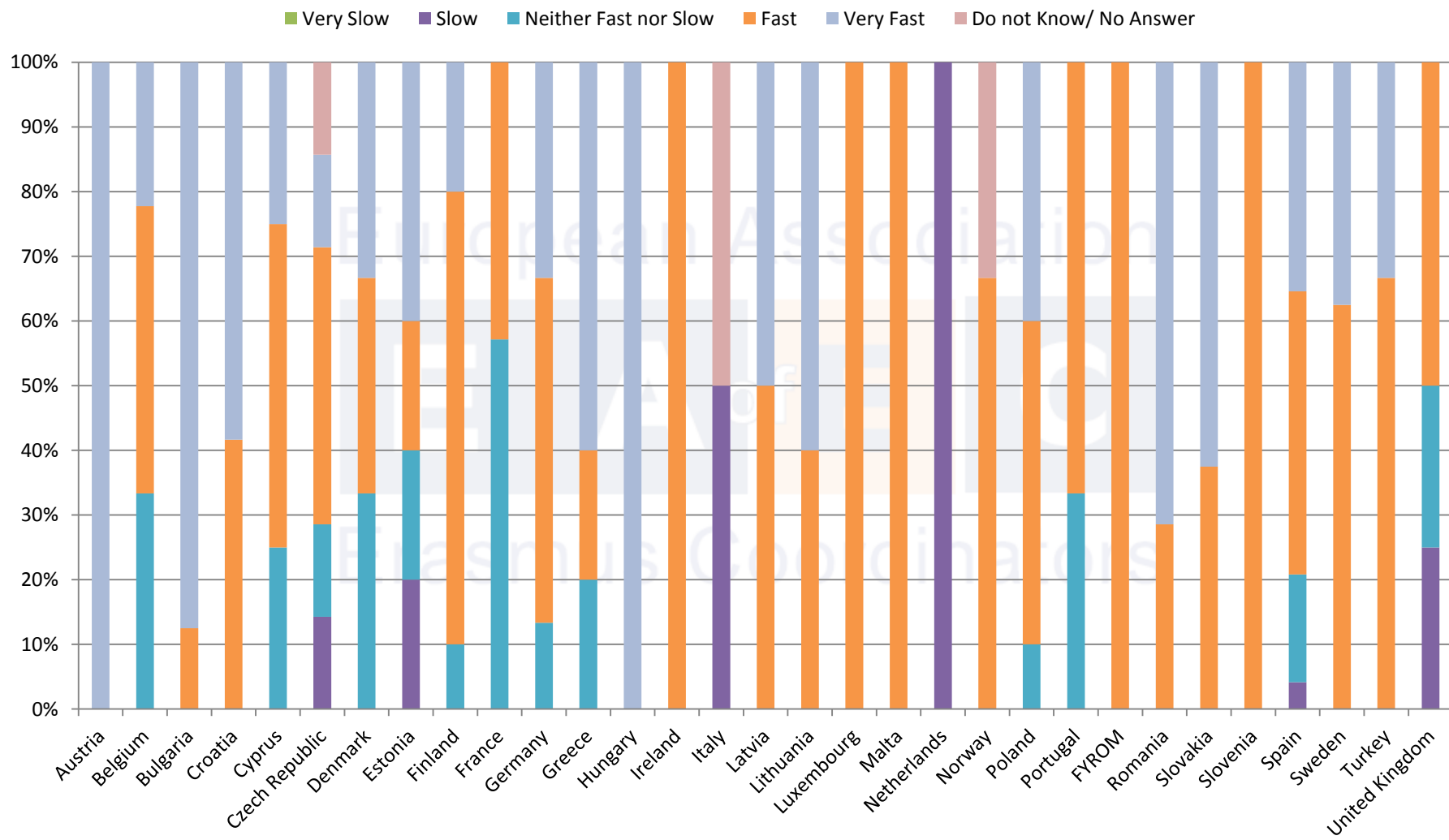
Do you get clear responses from your National Agency? Per Country (Question 18)

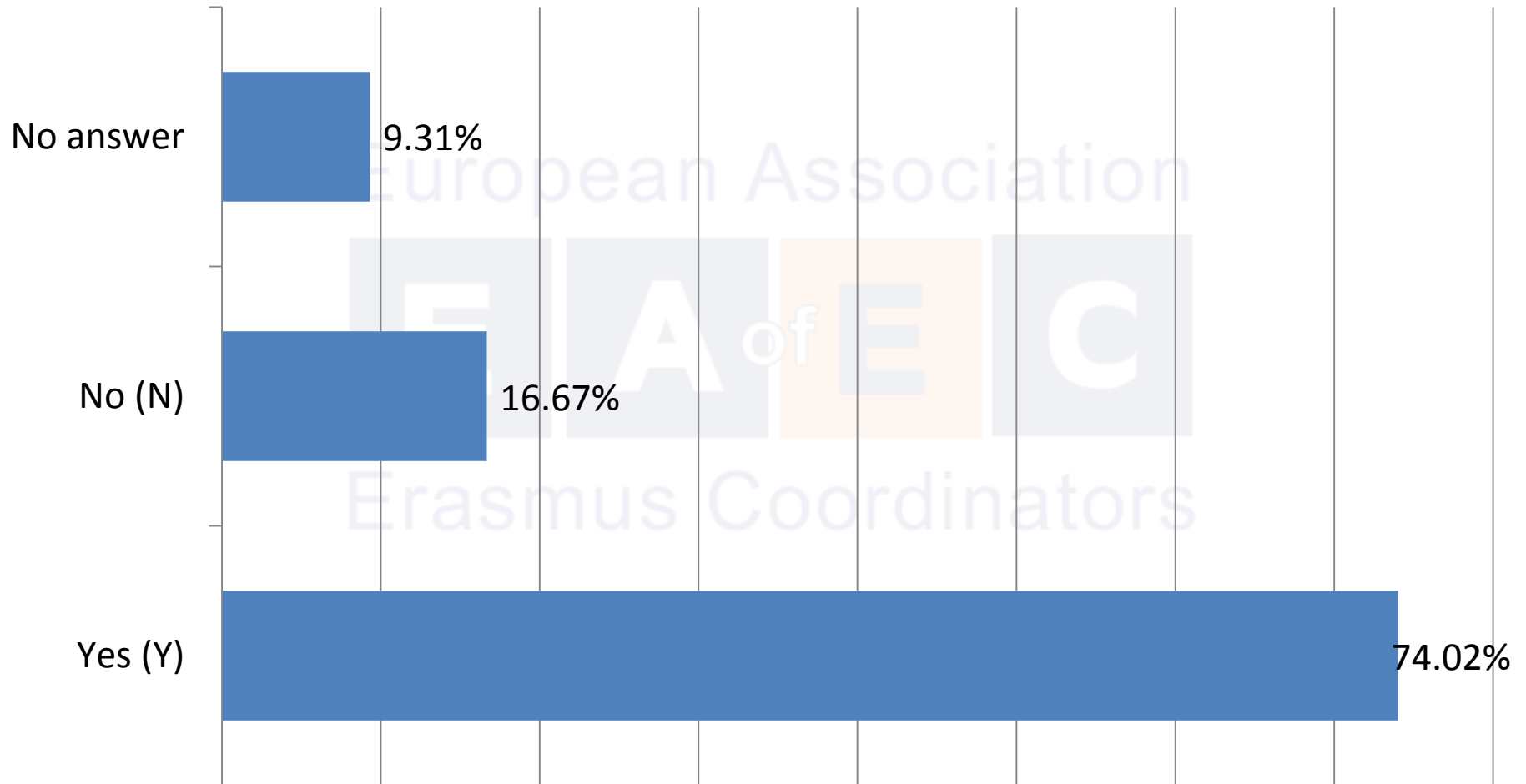

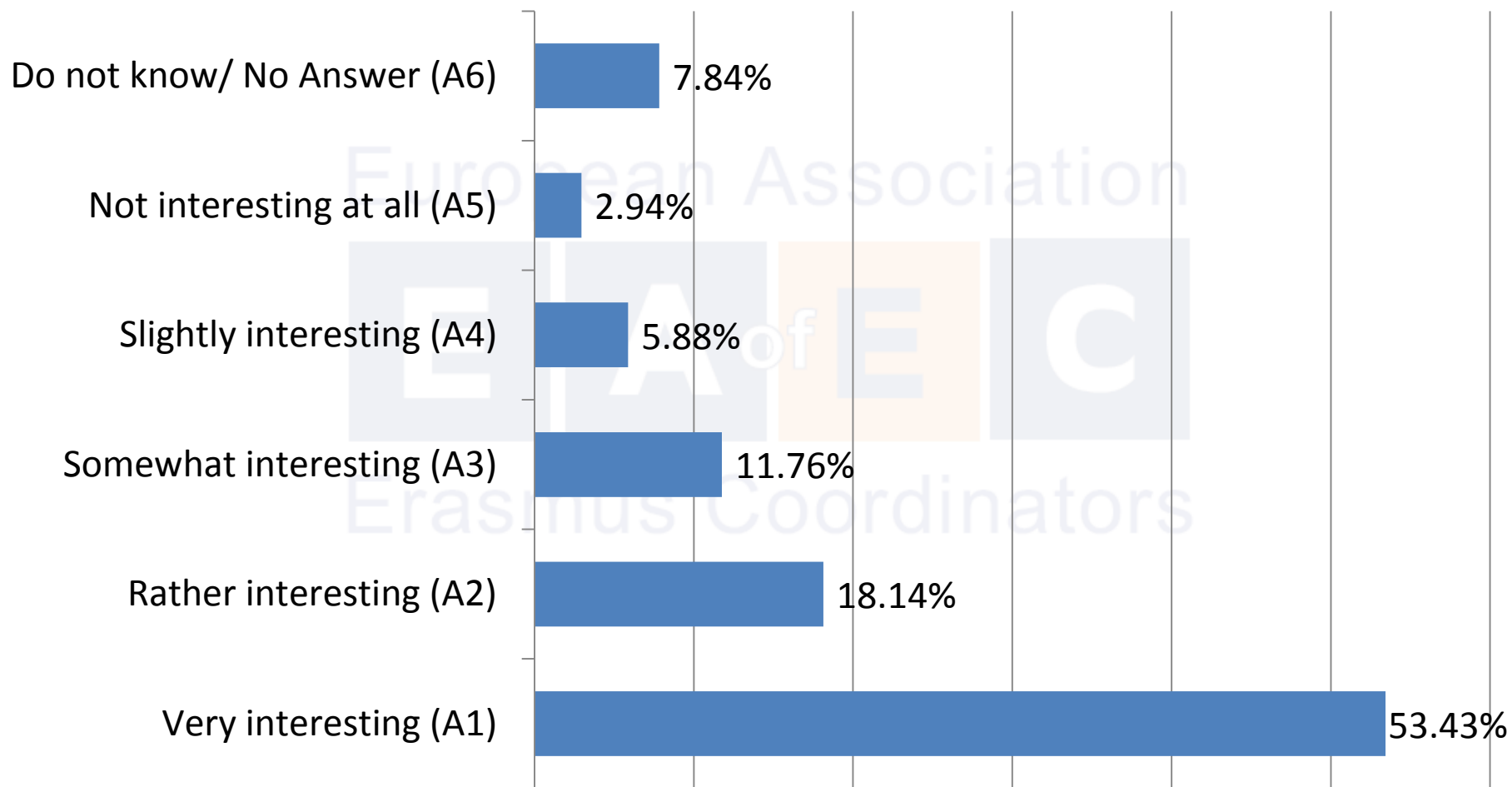

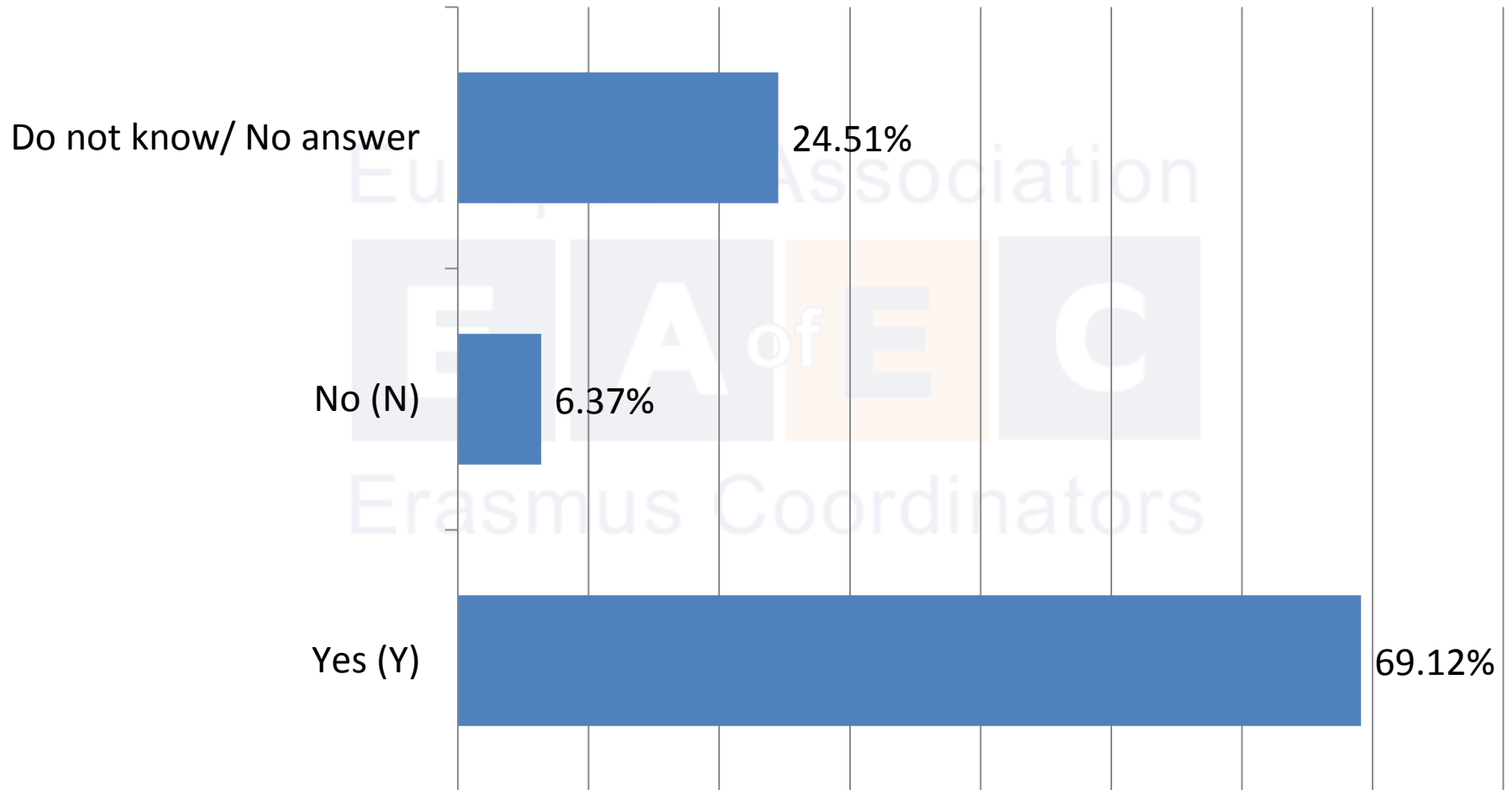

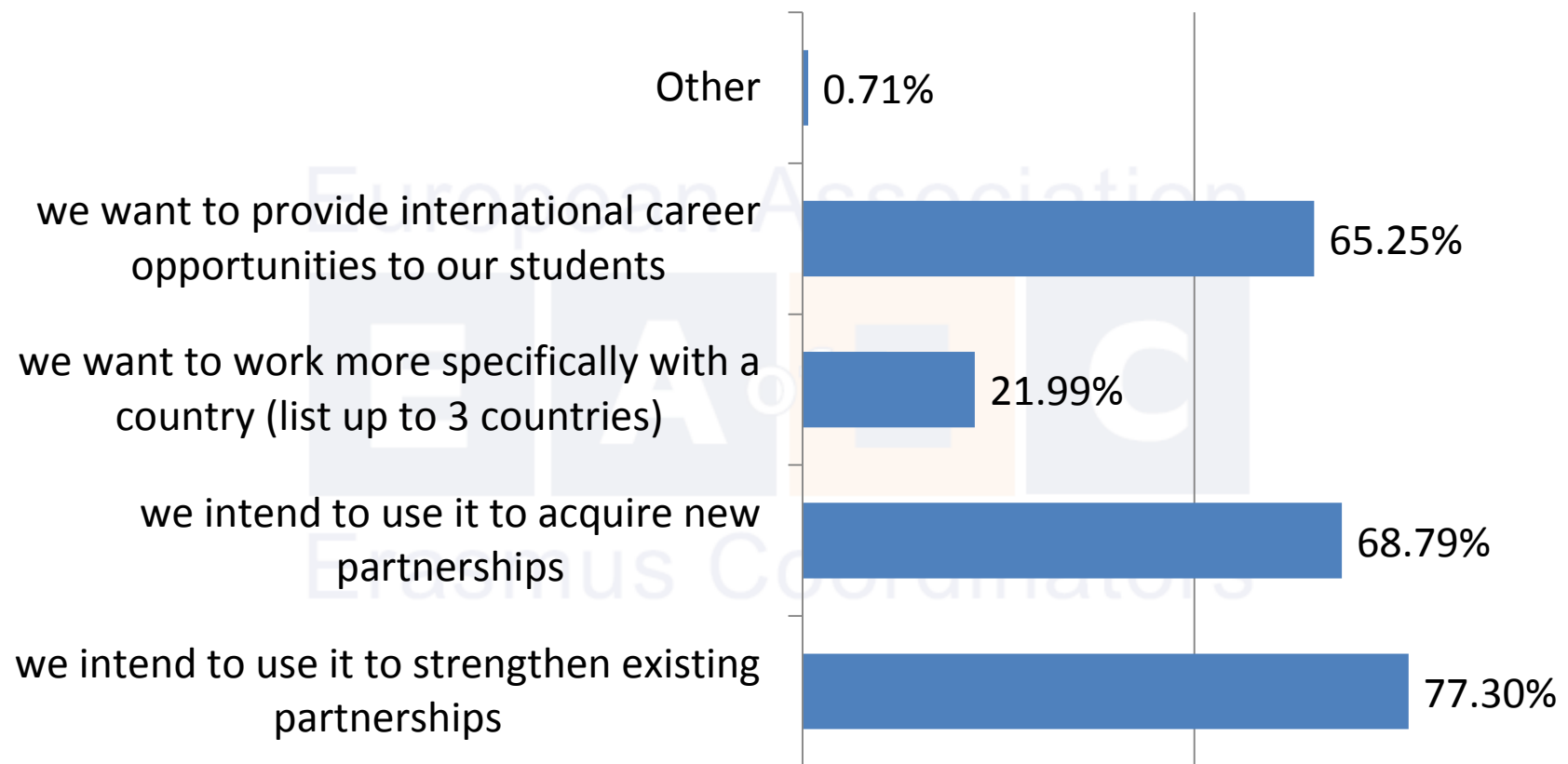

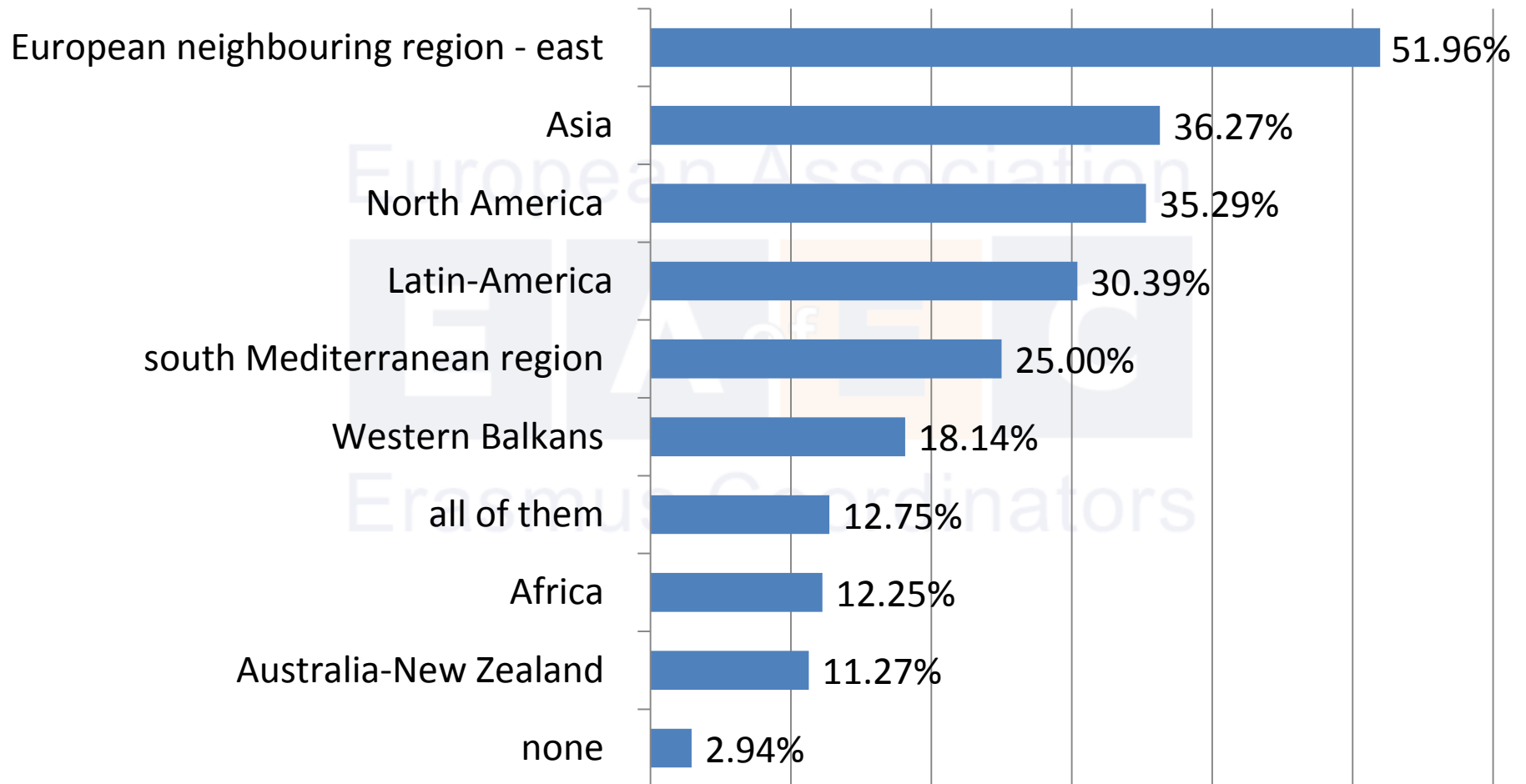
